

“The Acronyms Club”

Has the Ukraine Conflict Exposed the West and its History? The Most Comprehensive Study into How U.S. Hegemony Denies Sovereignties of Nations.

Abstract

Von Clausewits once wrote [in many of his aphorisms]: “War is the continuation of policy with other means.” (Howard; Paret 1974,). Firstly, this comprehensive body of research is an empirical attempt to purposely examine for the first time, how the West has continued to influence many countries without honouring their sovereignty. Secondly, this paper aims to validate, that the Russian Federation, made the correct decision by escalating the 8-year conflict in Ukraine, as a protectionary measure, thus, confirming the globe’s new “multipolarity” simultaneously; since the inception of military activities. Furthermore, this study will illustrate the decline of a unipolar world additionally via the US Dollar weaponization policies, resulting in denying sovereign states their dignity, from continuing confirmed illegal punitive sanctions. Thirdly, has both the three-year [SARS-CoV-2] pandemic, and the following Ukraine conflict, exposed the West’s true nature of an immoral gambit’s true nature more publicly? Referring to “The Acronyms Club”: US, UN, EU, NATO, IMF, WB and the OSCE, -has it been exposed within its hegemonic conduct, since the cessation of the Cold War? Fourth, it will be confirmed via documented history and acts recently that the UN Charter System i.e., Articles 3, 6, have been ignored on many fronts, consequently, the organization has become redundant and untruthful in today’s epoch. Fifth, this objectional hypothesis will notate the historic factors which has led to distrust of western society, by Eastern states; mainly due to its Western leadership of false promises with misinformation. Thus, has Russia’s action exposed an inflection point within the West and neo-liberal economic policy? Finally, the hypothesis being, why had the Russian Federation, purposely venture into Ukrainian territory, via “Special Military Operations” and was there provocation prior to doing so? Finally, has the Acronyms Club inadvertently or intentionally, created a “Cold War” 2.0 within Eastern trading practices?

Introduction

This research paper finally completes a trilogy of both works and research in an attempt to prove the hypothesis that the West has been rather a protagonist in global societal destruction in various meticulous guises, rather than being a purveyor of justice, freedom and proponent of human rights; which [as the data will suggest] was an elaborate falsehood. The two previous papers illustrated how the West applies many strategies to influence sovereign nations inclusive of their major advantage “Propaganda” via the media companies beneath their red, white and blue feet. (Miller, A.D. 2019; 2020).

Firstly, we would peer into the origins of democracy whence it came. In today’s world, the noun democracy is used and has been used as a sales-pitch from the West imposed onto other sovereign states by the “Acronyms Club” Moreover, with the added club’s subdivisions: the Atlantic Council and the Council for Foreign Relations which are neo-liberal so-called political think tanks. The aforementioned however, have all cited democracy for country interventions since at least 1893. From the outset, we would investigate why is democracy being used as a white flag for peace?

Democracy, a history: *Plato once agreed and stated that “democracy in a way leads to tyranny.”* Conversely, his teacher Socrates inferred “*Democracy was inherently corrupt, giving in to the will of the people who were inherently depraved*”. As we would agree, not a good beginning to the philosophically speaking. Permit me to delve further into the origins of this controlling narrative agent of society today.

According to the Oxford dictionary, the definition of democracy or *Demokratie* (Greek) is defined as a system of government by the whole population or all the eligible members of a state, typically through elected representatives termed the “... a system of parliamentary democracy”. In 507 BCE, an ardent Athenian man named Cleisthenes introduced new wide-ranging political reforms “*Demokratie*” or Rule by the People. In ancient Greek: Demos = People and Kratos = Power. This became adopted as a re-enactment in today’s world, but somewhat different to the originator’s model in the minds of the Acronyms Club. Allow one to elucidate further. As Athens was a given state of its own, The Athenians had the people make decisions by which they lived. The said voting populous controlled all parts of the political process.

Another state Sparta, was another to attempt or had tried democracy or *Demokratie*. According to the 4th Century historian Herodotus, the population comprised of the Aristocratic monopolies and middle-working classes of society and limited to 100,000 citizens, *metoikoi* (resident foreigners); whereby 40,000 only, were eligible to part-take in this democratic process. Scholars have written on this subject and how it compares to today’s democracy such as a dissertation written by a reader at Harvard “*Rethinking Athenian Democracy*”. (Cammack, D.L. 2013) One of the postulations was that Socrates in fact, was misunderstood and believed in “*mass representation*” in the whole process. This could possibly explain the disaffection of the democratic process from both Socrates and his former student Plato.

Today’s difference of democracy comparatively, would be obviously the classical Athenian system disallowed women, children and slaves from participation in the process, as they were not considered citizens. The similarities, however, were how both the Athenian and United States Constitutions on the “*Role of Government*” were written and therefore drafted into law. The classical form of Democracy ended in the fourth century BCE. Both Cleisthenes [Epithet: the father of democracy] and his son, were executed on the grounds of tyrannical acts whilst governing Athens and its suburbs. Subsequently, following numerous conflicts with losses, culminating in Macedonia conquering the country. The question we ought to ask ourselves; is this planet metaphorically in state bondage slavery even in these modern times?

The main difference of the epochal political systems (507 BCE – 4th Century BCE) the exemplar was the Athenian system had direct democracy - where they had their citizens vote upon new legislation, unlike in today’s world with the three branches of government modus. Conversely, could the three branches of government, be a negative factor in society of this era? The people do not control all parts of the political process; are we in agreement?

To conclude this segment of political origins, the types of people in any given sovereign nation, requires analysis. This paper will discern that in fact, “Democracy” has no distinct meaning as it is a noun being used for war by the West namely via its NATO’s allies

with the plundering a sovereign state's resources, since the "Cold War" inclusive of the collapse of the Soviet Union. An important question ought to be asked, then furnished with a credible answer: Should there be one formal democracy template for the whole world or remove it as the Greeks once had?

One's thesis is dependent on social variables. This world currently contains ~206 nations; according to the United Nations whereby 193 are members. Who decides this or is it a mere a talking club governed by the USA? - as the UN Headquarters is located in New York...? If there were two hundred plus nations globally, this would logically mean their Cultures, Traditions, Sovereign Borders or Frontiers, Religion, Constitutions, Protection of its Citizens, National Dress, Preservation of Histories and preservation of its National Security Protocols, would need to be the same respectively. However, this has not been the case and never will be under this hegemonic autocracy. This is due to the weaponization of both the noun "Democracy" and the US Dollar currency by namely the United States. Moreover, The US wishes to retain both NATO and its superiority in its desired uni-polarized world, even though, the evidence will elucidate those global affairs have indeed changed to a multipolar one. The US has simply justified its military incursions by using vocabulary as human rights, creating democracy, even though said nations had become failed states following the US and NATO engagement's departure.

Method

Ethical Approval: This study was approved for one's second Ph.D. via the Swiss School of Business Research. Nüscherstrasse 31, 8001, Zurich, Switzerland. Supervised under the instructions of Gürsel Illipinar Ph.D. for Institutional Jury Review thereafter. **Purpose:** to ascertain on basically how the conflict in Ukraine from February 24, 2022 came to pass, thus objectively gauge who were the protagonists of the escalation following an 8-year civil war previously. By doing so, has this finally exposed the West and its historic policies of global hegemony.

Literature Review

This review will commence by professing that not one research paper outside of the Russian Federation, has cited within its defensive hypothesis that one of Russia's main reasons for

the Ukraine conflict, was the expansion of the 15 nations within NATO, since the summit of both Gorbachev and Baker in 1991. How this has neither been recorded in any academic publications nor political scientific works, has astonished this researcher. It does seem, that this body of work and its conclusion, has been vilified by certain parties in the West, since coming into draft being, for the exposition of its hegemonic narratives. In the ethos of scientific counterclaim, this paper has sought the answers within the realms of empirical theory in the company of Kepler, Copernicus, and Galileo once had. One feels, this is excellent company to be within. The research findings which have been both illustrated and detailed in this paper, will show undeniable data that will prove one's original hypothesis that Russia had made the correct humanitarian decision to move into Ukraine's territory, on affect, to rescue the Donbass region upon the Lugansk's and Donetsk's plea for assistance. The literature gathered on this subject from academics mainly from 2022 due to the nature of the hypothesis dated within current events as this were drafted. Within the reference section, it can be seen that a historical academic cited account, will be found that attracts the contextual outline for the hypothesis itself.

Firstly, pertaining the oldest paper mentioned here in this section, Mearsheimer in his 2014 paper *Crisis Is the West's Fault: The Liberal Delusions That Provoked Putin*. One would concur with his findings; however, one would peer into the history of the protagonist nature of the West also to ascertain the psychological nature for US provocation towards Russia provocation towards Russia. Historical data indeed reflects this in the present, as the seed was sewn in previous generations. His thesis was indeed correct within Mearsheimer's assertion of neo-liberal antagonization of Russia in provoking its premier then and now. Therefore, this paper was the closest examined - that relates to one's research hypothesis. However, more historical data should have been included into how the West has conducted its interventions? Secondly, Dr Cristina Florea: A historian of Central and Eastern Europe at Cornell University, concurs with the hypothesis portrayed in this research in reference stating: *"The 20th century witnessed several attempts at reimagining forms of international cooperation*

and guaranteeing peace, from the League of Nations to the United Nations” unfortunately, the statement had only provided the western standpoint, neither acknowledging this study’s assertion that the US and NATO initiated the Ukraine conflict nor acquiring a more significant historical defence. Moving onto the third publication cited: Bandow’s report entitled *The Ukraine Crisis Could Spark a New Cold War (Or a Nuclear War) 2022* on behalf of the CATO Institute. One, in fact, will agree with the assertion that a neutral Ukraine would be the best outcome. However, one would counter that addition text was not inclusive of the theory stated as Russia was deliberately coerced into this war via ungentlemanly rhetoric. The Crimea was also Russian, as it was classified by the author as yet another invasion in criminal act, the writer would have seen the proverbial light by the reading of Tolstoy’s longest literary. A long history of Ukrainian state corruption was not cited at all. CATO unfortunately, followed its government’s thought processes, yet, once again, without surprise to this researcher. Fourth, in reference to Hunter, the 2022 study *The Ukraine Crisis: Why and What Now?* Illustrated this ambiguous statement: “West’s effort to create a ‘Europe whole and free’ and at peace. The West failed to convince Russia to play a positive role in Europe and to help it do so.” This paper has attempted to be balanced within objective opinions, however, one narrative within academic publishing seems to have been established. Within this study’s findings, the results within global published works, has purposed been biased within their nature. The hypothesis at stake, is simply why did Vladimir Putin, the President of the Russian Federation, purposely venture into Ukrainian territory, and was he provoked in doing so? The US simply and deliberately misinformed Gorbachev in 1991 following the Warsaw Pact being dissolved. Fifth, within Larsen’s *NATO in an Illiberal World* publication dated 2021, stating “Enhanced Partners” emanating from the West of the Balkans vis-à-vis non-neo-liberal states or as it’s written “Illiberal powers”. This would strengthen the alliance and would indeed assist in procuring the southern borders of Russia, in an attempt to encircle their so-called foe. This isn’t real science once more, as it has been reported since NATO’s expansion had begun. Obviously, this study concurs this, from its historical segments. Nevertheless, such enlargement actions would be

seen as a form of provocation to Russia, but not mentioned in Larsen’s study. Moving onto the sixth body of remarks within Matovsky’s paper *Why would Putin invade Ukraine? Troubles at home may be his strongest motive*. As per every western and academic source within the same region, the papers and articles were tainted with unverified data without substance. Therefore, the Matovsky report is no exception. As it has the initial undefended hypothesis that states that Vladimir Putin needed a war to appease the country’s citizens, without any form of corroboration. Obviously, it has countered one’s own theory on the Ukrainian crisis, nevertheless, there isn’t valid reason cited, to why Russia escalated the eight-year conflict in Ukraine. Not one.

To finalise this segment, it is evident since this researcher commenced vying to seek the truth, of why the Russian Federation ventured further into the Ukraine, the cited published papers from viable academics have been sparse in numbers and inconsequential, since the Special Military Operations were indeed initiated. One therefore, is convinced that politics has indeed infiltrated western academe. This is disappointing for an academic who emanated from the West, to bear witness to badly unimaginative academic works pertaining this subject matter. From the lack of credible scientific fact during Covid-19 [asked to be masked and being vaccinated] without empirical evidence, to this crisis in the Ukraine, and the Donbass region whence it came 8 years previously. Yet, at this moment in time, is still neither recorded, chronicled nor documented in the West by its news correspondents. It is a disgrace place upon any nation that sacrificed 27 million lives nearly four-score years ago. An ambassador being subject to a paint attack in Poland and the deliberate attempt by the West to remove 1500 documented years of Russian culture from the annals of history. Russia has indeed exposed the real Fascist West, which will be also exposed within this research for citable truth. The aforementioned papers shared a remarkable but unfortunate lack of argument *cum* evidence to support certain biased founded hypothesis. You as the reader, would have read that the real science has been premeditated - within its negation. Western Academic support a political narrative, rather than science fact to appease the US. UK and the “Chariot of War”

NATO. An organization of democracy and peace, has merely become a combined tool for war and destruction for everything that it has touched or intervened in. This will be clearly defined within this paper to you this day.

Professor Mearsheimer, has been closest and most consistent in his writings upon Western engagement, and was published in 2014. There has in fact, no scientific code of ethics paper that has been written on the subject of the US and NATO, following Mearsheimer's writings and addresses prior to this paper before you today. One's colleagues have versed this papers importance, as one has been threatened by the importance of its findings. The audience could finally bear witness to the true nature of the West, inclusive of its true intent. It is noted that "*A leopard doesn't change its spots*" This is indeed evident with the "Acronym's Club" hence its being the title of this paper. Allow one to commence the prelude and results of this long study with a relevant quotation: "*You cannot reason people out of a position that they did not reason themselves into.*" (Goldacre, B. 2011).

The United States of Hegemony:

His Royal Highness King Abdullah of Jordan once remarked "*Democracy means different things to different peoples*" This was the most intelligent statement that one has ever heard from an acting regal head of state. This concurs with the aforementioned analysis pertaining to culture differences as referenced. Since 1991 and both the dissolution, demise and fragmentation of the Union of the Soviet Socialist Republics (USSR), the United States of America had thought, they then had a freehand in global policing and being a conduit for global policy, thus, being an overseer of a new world order. This research has deduced that this world monopoly or unipolarity came to an end publicly, by Russian escalation in the Ukraine. The exposition of the West was now finally decerned within the public gaze. Consequently, the Acronym's Clubs' is now transparent with its pronouncements and actions within policy; as it has both been exposed and weakened by the Russian Federation and its allies in trade and security; in-so-far as creating a new division within a progressing multipolar global environment.

One will try to breakdown the whole meaning of what America is, and what it became from an important period of tyrannical conflict

and sovereign state manipulation in various guises within absolute context. The period of history which will be referred to is from 1893 to 2022 -a period of humanitarian shame. On January 16, 1893, with a coup d'état against Queen Lili'uokalani on the island of Oahu led by the Committee of Safety, the USA overthrew a legitimate sovereign constitutional monarchy which had led to an annexation, then becoming a colony in 1898. Following a 93% winning referendum it became the 50th State in 1959. This became the first documented coup d'état initiated by the West. Since this acrimony upon unthreatening people, much has been committed by this said nation of hegemony and false narratives: According to Dr. Dov Levin, formerly of the institute of Politics and Strategy at Carnegie Mellon University, [now residing in Hong Kong] calculated from his model of "partisan electoral interventions" US interventions globally accounted for 1:9 elections from 1946 to 2000. Which accounts for one in every nine competitive elections since WWII. (Levin, D. 2019) In addition, according to the Washington Post the US has in fact, attempted to change sovereign governments no less than 72 times during the "Cold War". (O'Rourke, A. 2016).

To exemplify US interference or incursions further, below in Table 1. Which was originally published in 2011 by William Blum and subsequently update by oneself. The main purpose of the data is to display America's actions without any form of ambiguity, thus, solely rely on factual history. Dear readers and academics, no matter the attempts to distort history, we cannot remove the past documented heinous acts of the said nation. Consequently, during the cold war The U.S. had attempted to change other countries' governments on seventy-two documented occasions inclusive of the West's denial of nation sovereignties in the process.

US Narratives that it Sells to the Public to Engage in Conflict with a Sovereign State:

As we have all witnessed, especially pertaining this recent war in the Ukraine between the Russian Federation and Ukraine; where one-sided narratives have been sold to the western public. We have to accept, the US has a winning formula with regards to spreading the word, even though, it may be misinformation. Its apparatus is to have as many news outlets as possible working as a well-oiled machine. Unfortunately, it is widely acknowledged it has the best propaganda mechanism in the world; from liberally-minded western media outlets, to social media platforms -conveniently located in Silicon Valley, California. We all have to admit to ourselves, this narrative megaphone is particularly brilliant, however, is this the last contribution to the world that the US will ever furnish us with?

Moving onto the **label tactics to instil a conflict**, we must retain reality. There are many forms of war today: Electronic, Conventional, Informational, Military and of course Economic via Sanctions. That being said, permit this research to illustrate contextually, how a conflict could come to pass at any time through historical context to the present.

Firstly, the United States must have a foe; meaning that a nation doesn't conform to a US narrative, and their way of life for this planet. Let's say a country fictitiously named

Serendipity, has a good life within its borders and respects its geographical neighbours with a population of say 50 million people; it trades with its neighbouring countries and regularly has the occasional summit. Nevertheless, if this said sovereign state were to disagree with US foreign policy, the democratically elected leader of said nation would then be targeted. At this stage an infamous quote comes to mind by Hermann Goering ***"The only thing that needs to be done to enslave people is to scare them."*** (Reuters 2021.) The scare tactic here is through misinformation or a gargantuan lie or falsehood. Referring to the quotation by Goering, one would could modify these scare tactics to anyone via these active verbs: Convince, Believe, Trust, Accept, Postulate, Affirm and have Faith. Then the constitutional leader of Serendipity would be subjected to widespread ostracization via the media orchestrated by the Pentagon. Allow one to provide some possible samples of propagandized western rhetoric that could be constantly chronicled falsely by said media outlets. Thus, the agitprops would be as follows to convince the public: *for... fair elections, new democracy, human rights, radical..., anti-corruption, violations, weapons testing, moral ignorance, liberation, freedom, against tyranny, against a dictatorship, crimes against humanity, communism, non-recognised elections, terrorism, war crimes, moral-luck Hazzard, non-compliance, lack of moral responsibility, terrorist acts, and international criminal court violations.* to name a few. Therefore, how many nations have been subjected to these narratives by the West, and eventually succumbed to it? We need not look far into history to elucidate... Once this propaganda is upon every news channel in the West, then the next move would possibly be a small military incursion with the addition of the diplomatic rounds to America's allies like NATO members to instil both confidence and belief in US action and its policy. Sanctions and social media would be applied trying to cripple the state. Eventually support would be mustered for possible unilateral conflict. With or without at UN charter, as it has been violated often before. Finally, Serendipity would be under the condition of war and its natural resources plundered.

Historical Context:

In recent memory, the United States has ignored the United Nations Charter on several

occasions. Why would the UN be required, if one power ignores its charters? Simply put, the UN and the Acronym's Club are alike, as they belong to the US. International Law of nations is used for the West solely. If a nation isn't taking part with the US, expect violations of the US charters and information campaigns with ostracization of the opposing country. Therefore, to alter the nature of a head of state, is the prelude to overthrowing a government, however, it would require immense publicity and marketing, in which the US can afford to finance and the application of its social media partners in Silicon Valley. According to the annals of history, the US has only targeted sovereign nations that possess an abundance on natural resources and situated in a favourable geographical location.

As the US conducts its conflicts possibly without any due care, or attention and merely advocates "Casualties of War", the Harvard School of Public Health begs to differ: "*Though, it's essential for the American public to focus not just on American lives lost in war, but also those of individuals in other countries, it was said. Beyond that, there are practical considerations; high numbers of civilian deaths can damage the U.S. reputation abroad and make it difficult to achieve foreign policy goals.*" (Chan 2011.) One would contest this notion, as in reality the US has no care for so-called casualties of war, and only American lives matter. The Ukraine will eventually ascertain that it has been duped by the West, and then it will calculate the Ukrainian lives lost by the thousand; certainly, no via an abacus.

A Difference in being Compelled to Action Compared to being Premeditated?

If we were to compare the incursions onto Independent Sovereign States instigated by the USA and Russian Federation since WWII, the following investigation has learned that the Russian federation has been involved in only 12 conflicts since its inception. However, compared to the Table 1. P.4. *Overthrowing of Sovereign by the United States of America* the US has been very active in coups, election meddling and military interventions even as far back 1893 with the state of Hawaii. In fact, the USA has been involved in a multitude of separate incursions upon sovereign lands -since not only World War II, but long before the dates cited in Blum's original Table 1. p.4., and these were empirically cited as premeditated actions. Conversely, the

Russian Federation was compelled to act, as in Ukraine from February 24th 2022, when the Donbass region requested its assistance from the barrage from the Ukrainian Nationalist Forces, for a period of eight years prior to engagement; in which the Western media failed to chronicle or has been deliberately hidden away from its own respective populations. We have all heard from the western press, politicians or the Acronym's Club that Russia invaded Ukraine? Well permit me to elucidate further this unsafe verb. TRESPASS implies an unwarranted or unlawful intrusion. hunters trespassing on farmland ENCROACH suggests gradual or stealthy entrance upon another's territory or usurpation of another's rights or possessions.*" Firstly, the Lugansk and Donetsk Republics invited the Russian Federation to assist them in their plight and need; ditto to an invitation by Ukrainian passport holders, of whom many were. This in itself, does not warrant an invasion. The definition above, certainly does not infer protection of its own ethnic citizens. Moreover, a war had already been in play and theatre for eight years prior to the request for assistance. Therefore, this was a legal act upon request from Ukrainian citizens of whom Russia had accepted in recognition of being independent previously. Additionally, this does not conform to the UN charter of Article 6. The Charter states: "*A Member of the United Nations who has persistently violated the principles contained in the present Charter may be expelled from the Organization by the General Assembly upon the recommendation of the Security Council.*" We must ask ourselves, why hasn't the Russian Federation been expelled as the above citation indicates? As the war had been continuing for 8 years and eastern Ukrainian citizens invited them, this was not a violation, but merely an escalation; certainly not an invasion. In modern liberal terms of this epoch, it was a form of humanity towards an ethnically Russian populous. In fact, the U.S. has been applying similar mantra for illegal colonisation purposes.

Whence it came.

Once upon a time there were Britain, Spain, France, Germany, Romania, Italy, and Portugal.

In one moment these seven nations once ruled and dominated the planet with their respective forms of colonization. Italy had northern Africa shared with France. France itself once had 50% of the continent of Africa, whereby Portugal, had a country many times its size -Brazil, while Belgium had its Congo. As the World War II holocaust had been a stain on Germany, Hitler's "final solution" was not an original concept which was acted upon. In fact, it was Britain that had its own concentration camp over a century ago. Parenthetically speaking, Dr Elizabeth van Heyningen, and a team of research assistants have been involved in the subject matter for many years. This noted academic is an Honorary Research Associate in the Department of Historical Studies, University of Cape Town and co-author of several books such as: *The Cape Doctor in the Nineteenth Century*. Additionally, has written a variety of articles on the camps. Van Heyningen and team members have the largest database on the British Colonial South African Camps.

One infamous camp was Bloemfontein in Orange Free State 1900-1902; an inventive holding camp which had conditions similar to the Nazi camps of thirty years later, but without the extermination. The camp's occupants were usually malnourished and suffering from maladies. Many fatalities could be indexed from the source in this paper's reference section. There were several other imperial colonies from other nations, the autochthonic suffering continued for laboured profit from the land's natural resources, for the colonial power, the money was good. In conclusion, these colonies lay the platform or foundation to neo-liberal economic thought that is being displayed this day throughout the West and being subsequently imposed onto other nations. In fact, it is argued to be the initiation of Capitalism; the vehicle of today's globalism as we know it. Thus, history of these events is not really taught within the High School classrooms. This is attributed to an inconvenient stain on a nation's history. Exploitation of the people and their land was very profitable. Does this resemble actions of dominant nations or so-called Powers today? A further question within the thesis ought to be asked; Was this the outset of "Fascism"?

With relevance to our own welfare, are we not exempt from savagery even though the new generation of students [with due respect],

understand the USA is "*The Land of the Free*" or is it really? They conjointly feel that the US voting-age population are the autochthonic; as we all know; could be misinformation, and they would believe it. If truth be known, the United States of America is associated in a progressive social experiment -if it tends to be adored or not...? furthermore, the US is solely comprised of 332,000,000 immigrants. The autochthonic Red Indians were just about wiped-out by the colonials resulting in a new version of Pan-Euro immigrant America. Therefore, it absolutely was the Indian Nation who were the indigenous population not the latter inhabitants. This evidence in step with David Smith of the University of Houston and also the author of: *Counting the Dead: Estimating the Loss of Life in the Indigenous Holocaust, 1492-Present*. This research conducted by Dr. Smith a renowned academic referenced the role of diseases, wars, genocidal violence, enslavement, forced relocations, the destruction of food sources, the devastation of the way of life, reduced birth rates, and alternative factors at intervals this autochthonic Holocaust. Exemplar i) The State of Hawaii:

This aforementioned unreported historical event moreover, a further stain on United States of America's history was upon the Hawaiian Constitutional autocracy -that once more, has not been mentioned in nineteenth century history. 1892 was the final year of this sovereign state's constitutional autocracy. 1893, the United States of America sanctioned a bloodless coup against the then monarch Lili'uokalani on the island. This was a rectifier by the Committee of Safety, that incorporated seven foreign residents (U.S.) and 6 non-aboriginal Hawaiian Kingdom subjects of U.S. descents, based mostly within the capital city. In 1898, Hawaii became

annexed. Decades earlier, white missionaries occupied the island till their descendants requested the USA to intervene with the overthrow within premeditation. America sent troops to the capital city to retain order. Nearly six decades later, Hawaii became the fiftieth State of the United States of America and also the forty-ninth being the Last Frontier Alaska, each being legal in 1959. (US, DOS. 2009). In context, it is written that Hawaii's overthrow was because of the European nation's own interests within the island, each geographically located for provisional logistic functions.

To conclude this additional miserable episode of intervention, one refers you to Table 1. p.4. Hawaii has been worthy of insertion to the list of the sovereign nations whose government and regality were so overthrown by the USA.

As you've been reading this third body of analysis in this paper, it's become clear that the U.S. has been concerned in some unscrupulous international seeded policy practices over two centuries. The data has delineated to this point that it is evident that seventy-two sovereign states, have had their various governments and leaderships overthrown for resource gain. The treatment of their voters is attributed to several law of Humanity violations. Sadly, the United Nations Charter was too late for many sovereign nations that had endured and succumbed to the United States of America's bullying to being antecedental. To conclude this segment referring to an apt observation a young writer and litterateur of the World Health Organization, published under his *nom de guerre* Criss Jami, wrote: "*Man isn't, by nature, worth of all that he wants*" -thus, the US uses force and information to initiate its intent upon the globe."

Is the West in possession of fascism?

Firstly, please allow this paper to tell apart what will this hateful term suggests that definitively as a political dominant construct? in step with the Merriam Webster Dictionary: "*A political philosophy, movement, or regime (such as that of the Fascisti) that exalts a nation and infrequently race higher than the individual which stands for a centralized autocratic government headed by a dictatorial leader, severe economic and social infliction, and physical suppression of opposition.*"

Highlighted above, the definition cited which would be needed to discern the Acronyms

Club's volatile hegemonic thesis. This paper will continue to illustrate the dimensions within the hypothesis of the West's both historical actions to today's policies; that have included forms of citizenry control and manipulating of non-allied Eastern partners i.e., a Maxim for the West to be established empirically, morally and cohesively within science objective fact.

Fascism: Has it indeed been occurring for over a Century?

As we have already defined Fascism from both the dictionary and cited examples of such nationalist behaviour, allow this paper to indulge you in another example from World War II to the present day. Some surprising facts will be unveiled in this section of this document. The following will display and clearly illustrate how fascism came pass, and how relevant it appears to be in the second decade of the twenty-first century; these have been already divided into segments of "*exemplars*" for clarity and directional analysis:

Exemplar ii) The Tyrol - Northern Italy versus Benito Mussolini:

If history were to repeat itself to this year's crisis in Ukraine, we would no further look than the German-speaking and ethnic South Tyrol, located in the Northern Italian Alps. The South Tyrol, was once part of the Austro-Hungarian Empire, was a part of Italy via annexation in 1919, following the end of the World War I. Italian initial ambitions were to have control from the Brenner Pass. Many people here are native German speakers, and a few of them, alike the War Graves Association, are still not reconciled to the fact that the province has been part of Italy for almost a century. According to the BBC news media, the two decennaries between the 1920s and the 1930s Italy, had a fascist leader named Benito Mussolini and he encouraged southern Italians to settle in the region, and had attempted to remove the German language from the Tyrol itself permanently. Tyrolians were given a choice: "*join the Reich and negate their homeland, or integrate into Italy as Italians.*" (Bell 2012,) There were bans in German to be spoken in schools and municipal offices all at the behest of Mussolini. Streets were renamed as a part of his nationalist Italianization ideals. As we can clearly concur, Mussolini's acts of fascism were mirrored to this day with Ukraine's pronounced legislations.

Facts from history that ought to be included in this analysis: What was Russia's contribution and how they were thanked by the West?

For the uninitiated audience due to the lack of military historical knowledge because of the generation gap, allow one to explain the USSR's contribution in World War II. As Nazi Germany marched to encroach onto Russia's Eastern front, The USSR Red Army had surmountable challenges as it had to face no more than 200 Nazi Divisions, compared to the meagre 40 Divisions the US and Allied Forces had faced. In addition, the United States were not directly impacted by the war on its soil as too its population -if we can accept the Pearl Harbour attack on December 7 1941 which was located nearly 9,000 kilometres away, this may be included. Population centres were not directly attacked as likened to the London Blitz in the East End or Coventry, inclusive many other domiciles throughout the European theatre; or emphatically Russia's Leningrad; namely St. Petersburg today.

If it were not for the USSR's sacrifice, the victory in Europe over Adolf Hitler, could never ever happened. Europe would be speaking German at this moment. One does use the verb "sacrifice" for a very good reason, by the time the Red Army arrived in Berlin: - according to the National World War 2 Museum in New Orleans: their sustained casualties stood at 24 million and many more unidentified both civilian and military; compared to the allied forces: USA: 418,000, The UK: 450,000, Yugoslavia: 1,000,000 and Poland as another example casualties totalled 5.6 million. There lay the Soviet Union's sacrifice. When the War in Europe was over, the other conflict in the Pacific was not. The Allied forces were having tremendous difficulty in the taking of some remote but key strategic islands in the Pacific, and there was a further adversary lay in wait in Manchuria on mass. The Kwantung Army formed in 1919, was an army group of the Imperial Japanese Army and it lay in wait for the Allied forces to attack. The Japanese in fact, had feared the USSR entering the Pacific regions' theatre of battle. Nonetheless, owing to the fighting spirit of the Russians, they were convinced to assist by the engaging of the Kwantung Army, even though this Japanese detachment numbered over a million strong. The result was the most convincing victory in the

history of the second World War. As the Japanese were defeated in all sense of the word, the US took it upon itself to still bomb Nagasaki and Hiroshima even though, it wasn't necessary militarily. The only reasoning laid here, was that the West wished display a show of force to Russia to not interfere with America's post war plans. Therefore, as yet not dared to be mentioned in literature to-date, the US used "little Boy" and "Fat Man" had two messages, one to the former Empire of Japan, and the second to Russia as the ultimate hegemonic deterrent for the world to come "Post War".

Since the aforementioned conflicts had ceased, there were further plans to completely destroy the USSR being formulated, 5-6 were rejected until one was chosen entitled: Dropshot plan envisaged that the US would attack Soviet Russia and drop at least 300 nuclear bombs and 20,000 tons of conventional ordinance on 200 targets. This was in the planning from 1945 to 1949. German philosopher George Hegel once wrote: ***"The only thing that we learn from history, is that we learn nothing from history"***. No wonder military actions repeat themselves to this day. Please refer to this editorial for further reference: *"Don't forget how the Soviet Union saved the world from Hitler."* (Tharoor 2015.) It was remarked by Winston Churchill from his home in 1956, stating that: *"Stalin never broke his word to me"*. (Sulzberger 1970.)

For example, a changeable Churchill then made up his own mind and wished for the Anglo Saxons to destroy the Russian Slavic Race with 100,000 German Prisoners of War joining the Allied Forces; a very ambitious 1945 plan named: "Operation Unthinkable" Therefore, the true intentions of the West upon the Soviet Union commenced. Joseph Stalin's intelligence was aware of the said plan; and Russian troops were hastily deployed to strategic positions from Berlin to its periphery. This thwarted any attack and in consequence, the end for Churchill's plan for the USSR's annihilation. The 1949 Operation Dropshot plan envisaged that the US would attack Soviet Russia and drop at least 300 nuclear bombs and 20,000 tons of conventional bombs on 200 targets. This plan was halted in the late 1950s due to Russia entering the nuclear arms race. Even in the ninth decennial, plans continued to be drawn for conflict against Russia; whereby proxies were being formed onto the Federation's frontiers to this day.

Exemplar iii) Yugoslavia 1999, NATO Illegal Attack “A WAR CRIME?”

An American reformed theologian and ordained pastor (1939-2017), once coined this expression: *‘It doesn't matter what you believe, as long as you're sincere, is a monstrous lie.’* One of whom authored this research paper deems this quote to be appropriate for this segment on the former Yugoslavia, specifically Serbia and Montenegro. Following NATO's indiscriminate bombardment of Bosnia Herzegovina in 1995 which had inflicted innumerable casualties throughout this Balkan conflict, four years later. “Operation Allied Force” was applied to Yugoslavia on March 24 due to the issues in Kosovo from 1998, coined the justification for both the US and NATO to cite psychiatrist trained Radovan Karadžić the then President of Republika Srpska, and is General for alleged war violations. Following one's own research over two decades, Yugoslavia and the Russian Federation consider their relationship as brothers and sisters owing to being Slavic peoples, with the addition of Yugoslavia's economic independence including a policy to not to join NATO. This conclusion fits the both the US and NATO coercive pushed narratives of their past conflicts. Without prior agreement nor permission by the United Nations Security Council, NATO under the leadership of Supreme General Wesley Clark, initiated the shelling of Serbia and Montenegro. Bridges, Civilian neighbourhoods, and small villages were deliberately attacked indiscriminately, leading to carnage. Citizens were cut to pieces by the shelling. All facets of civilian society were affected over the bombing duration. During this terrible escalation - specifically between March 23 to its ending following 78 constant days of attack on civilians, the NATO bombing of the Radio Television of Serbia (RTS) headquarters, occurred during “Operation Allied Force”, when strategic missiles struck the building during the night. Sixteen employees of RTS were killed outright with the same number being injured. Noam Chomsky even cited this “...as an act of terrorism.” In fact, the US and NATO or the same thing, attacked a force that was one thousand times smaller; one would ask why haven't these two been subpoenaed for war crimes?

These NATO incursions and subsequent acts of tyranny which were not countenanced by the

UN, must be classified as War Crimes. Ironically in closing, both Radovan Karadžić and his General Ratko Mladic were brought to the United Nations International Criminal Tribunal for the former Yugoslavia, were responsible for the planning, instigation, ordering or otherwise aiding and abetting in the planning, preparation or execution of the crimes referred to in the indictment. One question ought to be answered clearly: Why wasn't both NATO and the United States in the dock with these men? Considering Operation Allied Force was responsible for over 3000 civilian deaths and a multitude of injuries - inclusive of amputees. One refusal on the matter of Kosovo to a US delegation was no excuse to shell innocent people without UN Security Council Permission. This lays the ground and suspicion of the *function of the United Nations, and yet, who is its master?* The aforementioned conflict was outlined quite well by one's research of the publication: *Misfortunes of War: Press and Public Reactions to Civilian Deaths in Wartime.* (Larson; Savych 2007.). Owing to propaganda established within Western epithets alike Crimes against Humanity or War Crimes, we have seen over many decades through documented history -that both the UN and USA have and had conveniently accused nations which do not wish to join them in collaboration nor conform to its neo-liberal ideology *cum* fascistic forms of Capitalism; in turn, regularly become victims of NATO. In conclusion, as intelligent minds of fact and critical reasoning, one occasionally encounters overused phrasing; *exempli gratia “International Law”* It is said: *International Law only exists, if it serves the US, if it doesn't, it doesn't exist.* (Roberts 2021.)

Exemplar iv) Libya now a failed State... in context:

Whilst one was personally engaged in Libya within an educational capacity between (2008-2011)., one had witnessed a completely different country compared to the falsely charged rhetoric being voiced by the US Department State and the United Kingdom. The late Col. Muammar Gaddafi of whom succeeded King Idris in 1969 via Military Coup was quite ruthless, yes, however, Gaddafi knew how to enrich his country's infrastructure and citizen's living standards, as King Idris's reign was a failure since they had struck oil. Muammar Gaddafi's achievements were numerous. As the reader of

this paper, one implores you an answer to this question: How many nations are you aware of that had: free Electricity, Healthcare and free education for its people? Well, under the leadership of Gaddafi, this was achieved. Additionally, Gaddafi was well-liked on the African Continent. Yet, once more, only NATO - predominately the UK and the US that had despised this leader. In fact, even experiencing a long embargo, this North African state survived without Western dependence. Italy, a historic Libyan connection, extracted oil from the Northern Sahara Desert. Owing to Gaddafi's successes without compliance with the West, the US with its allies decided aggressively to remove a western labelled or so-called "dictator" from power via a fictitious propaganda narrative under Hilary Clinton's stewardship. Gaddafi was consequently promoted as a tyrant, by allegedly going to commit genocide upon his own citizens. This unconscionable geopolitical deed was accomplished when the Eurofighter shot down Libyan Jets ironically piloted by contracted Ukrainians which had led to the expansive movement from Benghazi; culminating in the resulting barbaric assassination of Gaddafi himself in 2011. As a result, Libya is now unrecognisable due to ongoing civil war, and political insecurity, has rendered it a failed state. Thus, the United States have decades of experience of creating failed nations and sovereignty removal.

Both the US and NATO, with misinformation one again to validate Gaddafi's overthrow. As leader, 140 different but ethnically random tribes and clans had to be merged; many of which had influences outside of the country. If we recall, the late Saddam Hussein of Iraq, this leader had a similar issue with the triad of religions to control. Under the auspices of the USA yet again, both leaders perished for their countries' natural resources, however, Gaddafi had no debts and was worth approximately \$200m Dollars. Could he in the end, had made one crucial error? -we must ask ourselves this question: had Muammar Gaddafi developed nuclear weapons or had indeed purchased some, would he have remained alive, and still be running his oil rich nation?

Exemplar v) On how many occasions has US Attacked other Sovereign States, Without Consent from the UN Security Council?

To conclude this segment, the United Nations'

duty to the world has come into question of its usefulness, due to its alleged or quite visible country biasness. Has the UN in fact, leading to a collapse, as the former League of Nations once experienced? Many academics in the political sciences in the Eastern social-sphere have realised that the UN exists to serve the purpose of the United States, if it doesn't, it doesn't exist. The UN Headquarters is located in New York - not a country of neutrality. The very same existence mirrors all of the "Acronyms Club" including the think-tanks as the Council for Foreign Relations and the Atlantic Council: propaganda arms or spokesmen for American foreign policy. In short, this is a one-directional foreign policy club. Militarily we could include USAID which is answerable to the Pentagon, and is conveniently introduced to lesser developed nations by its in-country situated embassies. On its own website it states: "*USAID works closely with the Departments of State, Defense, Treasury and Justice, and other government agencies to carry out development programming around the world.*" As prescribed and denoted on its own website...This body of research has also uncovered that USAID disguises itself as a regular NGO within the countries of operation. It is beyond any reproach via the UN. Revisiting the UN security council, are we still in need of this? As remarked in a 2009 research paper: "*(1) Security Council membership does not reflect today's world; developing countries are underrepresented, and there are no permanent members from either Africa or Latin America; (2) five permanent members enjoy veto power and frequently abuse their privileges; and (3) there is a lack of transparency and efficiency in the Security Council's decision-making process.*" (Lin, W. 2008) In conclusion, Both the USA and NATO had on three recent occasions: Serbia 1999, Afghanistan 2001 and Iraq 2003, were recognised as violations of the UN charter, therefore, was not countenanced by the Security Council. One would ask, if the UN was never subjected the US to sanctions or a War Crimes Tribunal, why tolerate this organisation further? As the US justification for the attack on Iraq *esempio gratia* was built on disinformation thus, false narrative to world that the Arab nation had weapons of mass destruction which has been well documented. Secondly, the loss of life in the three incursions, were unprecedented in the loss of civilian casualties. The war in Afghanistan consequently had thousands of casualties, with

arms manufactures was very good business -a further reason whereby the UN ought to become redundant. It too, alike other members of the acronyms club, has blood on its hands.

The Republic of Ukraine a brief, but Nevertheless a Revealing History:

In all guises of research – academic or non-academic, must record checks in viability and validity from the source’s origins. A history of all subject matters ought to be discerned as a main construct to relate to today’s actions or inactions to empirically define one’s thesis. One would denote from a historical standpoint (in this case) the origins of Ukrainian politics. The layman of whom isn’t versed with researching history from non-viable sources, that the Ukraine could not ever be connected or related to a litany of historic Nazism tendencies; in fact, you’d be wrong. Let’s delve into the 1930s and 1940s onward for this country that has been in the news recently with its military argument or discordant relationship with the Russian Federation. Moreover, how does Ukraine’s distant past actions, have any relationship to 2022’s conflict? Secondly, as we investigate fascistic relationships connected to the Republic of the Ukraine, and Third Reich’s sympathizing, which NATO and the West today, conveniently ignores; resulting and remains unrecorded within their media outlets. The study has learned throughout military history, propaganda inclusive of misinformation has been the marketer for acts of war. Alike today, only the convenient data which has fulfilled one-side’s narrative; wins the day. Especially upon the advent of the “Fourth Estate” digital media, which has taken propaganda to a whole new level; with the added unproven assertions or unquoted sources. In one’s own current experience, the students of whom one presides over, have unfortunately become bereft of critical thinking skills to discern the truth, and devoid of historical fact upon an international scale, at the behest of socialist left-leaning nations. In fact, this is due to lack of international history presented to high school-aged pupils. Therefore, students are controlled not only their learning of history, but their learning in the present. This was clearly proven in one’s previous research on education. (Miller, A.D. 2020). An Acronym’s Club ploy from one’s research named as a “Hegemonic Citizenry Control Narrative”. (HCCN) “A series of control

narratives to prevent citizen dissent against an unseen government-controlled ruling policy...”

In the second World War, Ukraine succumbed to the Third Reich by becoming collaborators. According to Paweł Markiewicz of Perdue University, this collaboration with Hitler was: chiefly through the perspective of Ukrainian Central Committee head Volodymyr Kubiiovych, a prewar academic and ardent nationalist. The contact between Kubiiovych and Nazi administrators at various levels shows where their collaboration coincided and where it differed, providing a full understanding of the Ukrainian Committee’s ties with the occupation authorities and its relationship with other groups, like Poles and Jews, in occupied Poland. In recorded history, other minorities as the “Slavs” were the first to be targeted. Under the “Waffen SS” some of its recruits were vicious Ukrainian born officers and non-commissioned officers. In fact, they aided the Nazi Regime in the first attack on Russia. Secondly, they occupied their concentration camps as guards for duration of the war. This body of collaborators were accompanied by soldiers from the Baltic region; namely: Lithuania, Estonia and Latvia; all of which were involved with the Nazi atrocities that occurred in this unsavoury wartime epoch. “Ukrainian nationalists’ collaboration created an opportunity to neutralize prewar Polish influences in various strata of social life. Kubiiovych hoped for the emergence of an autonomous Ukrainian region within the borders of the General Government or an ethnographic state closely associated with the Third Reich.” (Markiewicz, P. 2022). This inevitably led to a Third Reich partnership and therefore led to the Ukrainian-Poland conflict.

Moving onto a known Right-Wing Nationalist, Stepan Andriyovych Bandera circa (1909-1959) was a Ukrainian politician, Nazi collaborator and was a theorist of the militant wing of the far-right Organization of Ukrainian Nationalists. Moreover, was a leader and ideolog of the Ukrainian ultranationalists and revered by his subordinates. Bandera and his brethren were involved in numerous terrorist attacks, culminating to his accession to the OUN national executive in Galicia in June 1933. According to Grzegorz Rossolinski-Liebe is a Postdoctoral Fellow at the Friedrich-Meinecke-Institut of the Free University of Berlin, in his book (Rossoliński-Liebe, G. 2014).

Stepan Bandera: *“The Life and Afterlife of a Ukrainian Nationalist Fascism, Genocide, and Cult.”* explained within clarity how both fascism and racism had indeed had an impactful part upon Ukraine’s dark odious history within revolutionary and genocidal nationalism. It is clearly referenced how Bandera failed in his notion of ethnic cleansing. And how his state was under the auspices of the Nazis -inclusive of collaboration. It is also notated that this collaboration, therefore: *“examines the involvement of the Ukrainian nationalists in the Holocaust and other atrocities during and after the Second World War. Basically, this publication illustrates well Ukraine’s complex hidden history.”* (Rossoliński-Liebe 2014.). To be clear, June 22, 1941, three million German troops invaded Russia in three parallel angles of attack, in what is the most powerful invasion force in history. Nineteen panzer divisions, 3,000 tanks, 2,500 aircraft, and 7,000 artillery units, with the Ukrainian Nazi Collaborators participating as 3rd Reich uniformed soldiers., this event was known as Operation Barbarossa—the invasion of Russia. Secondly, these vicious Ukrainians were pushing Jews and other Nazi undesirables into the Gas chambers, assisted in the attacking of Slavic villages; committing mass murder and being involved in the destruction of Poland. Yes, from all the data gathered, it is beyond academic debate, that the Ukraine has been a part of the odious apparatus of Nazi influence from 1938 to the present. According to a recent editorial by Al Jazeera on March 1: *“Today, the neo-Nazi group the AZOV Battalion ironically trained by via NATO, and privately funded by financiers of was Jewish-Ukrainian billionaire and oligarch Igor Kolomoyskyi”* We need not use science to realise this is some contradiction. As for the defence of President V. Zelenskiy being a Jew himself, so Ukraine cannot possess neo-Nazis, is further western version of misinformation?

Ukraine was once and still the most Corrupt Country in Europe?

To say this research investigation on this segment uncovered archives and documents which one could not be objective as the evidence was somewhat overwhelming. To say that the Ukraine has and had systemic corruption would be an understatement. According the CATO Institute’s Ted Carpenter this year: *Ukraine has long been one of the more corrupt countries in*

the international system. In its annual report published in January 2022, Transparency International ranked Ukraine 123rd of the 180 countries it examined, with a score of 32 on a one-to-100-point scale. The Russian Federation was modest by comparison. However, Mongolia that is a part of this overall paper - included in the first draft, is not doing much better in this index: in 2021 registered; 110/180 and 30/100 respectively. NB: The very same global monopolization led to the Mongolian youth protests in March 2022 in Central Asia. Moreover, Western intervention in mining contracts and overseas investments has led to its own systemic corruption. In fact, according to Transparency International Mongolia dated 2012, 69% of the population believe corruption is a big problem and a further 22% of public sector employees believes bribes are accepted in some facets of the government departments. (Miller, A.D. 2019).

Ukraine: A country not a symbol of freedom and liberal democracy:

Within its recent report by the CATO Institute, Mr. Carpenter [reports author] enlarged on his investigation by specifying that: *“prior to the current Ukraine War, forms of intimidation via authoritarianism in Ukraine’s political governance.”* Carpenter also states that: *“Just months after the 2014 Maidan revolution, there were efforts to smother domestic critics, which accelerated as years passed. Harassment then commenced with Ukrainian current elected President Zelenskiy’s henchmen vetted their anger upon the political dissidents, Journalists - foreign or domestic, then adopting censureship, then a ban on journalists; generally, to be barred if they were to criticize the Ukrainian government and its policies.”*

President Volodymyr Zelensky following his indecisiveness within his own decision-making process, has now used his ***self-inflicted conflict***, as a justification for banning and ostracizing eleven opposition parties and nationalizing several media outlets. Those are hardly appropriate measures in a democracy, even in wartime. (Carpenter, T.G. 2022). Within the apparatus of bombing civilian domiciles with D30 Cannons is no justification in the name of democracy. As this objective research has discovered throughout, is that “Democracy” is a mere noun only. It certainly has no context within today’s world. This war and the previous

incursions alike the ones previously notated, have illustrated this decisively without a smidgen of ambiguity.

According to Amnesty International, this action was criticized by them. Moreover, the neo-Nazi Azov Battalion was an integral part of President Petro Poroshenko's military and security apparatus, and it has retained that role during Zelensky's presidency, this time criticized in reports from one of the Acronyms Club: Human Rights Watch, the Organization for Security and Cooperation in Europe, (OSCE) 2022 stated that "the neo-Nazi Azov Battalion was an integral part of President Petro Poroshenko's military and security apparatus, and it has retained that role during Zelensky's presidency."

President Joe Biden once remarked: President Zelenskyy was democratically elected. He's Jewish. His father's family was wiped out in the Nazi Holocaust. And Putin has the audacity, like all autocrats before him, to believe that might will make right. One has to disagree with his utterance, as the evidence of Nazi Battalions within the Ukrainian Army is beyond dispute, with another oligarch Jew Igor Kolomoyskyi who is the financier; as remarked in prelude 5. p.10. (Para 1)

To expand further into the murky history of Ukrainian corruption, we ought to refer to a quarterly paper written back in 2002 entitled: *Corruption in Ukraine: Essence, Scale, and Influence*. by Igor Zhdanov. In his introduction he describes Corruption: is a social phenomenon that has a vividly pronounced political background. Historical experience bears witness to the fact that the heights of power have often been achieved with the aid of corruption. At the same time, corruption has often caused the careers of politicians and governmental figures to end, and governments to fall. It has led to the change of political regimes and the decline of states. (Zhdanov, I. 2002). As an exemplar to this state's corruption cycle; from 1994 to 2020, there have 5 major ministers that have faced corruption sentences.

Following by a comprehensive report published by Carnegie Europe in 2016, and financed by George Soros's Open Society Foundations, they concluded that Ukrainian Corruption is a system that was badly weakened by the Euromaidan protests but has survived,

and, to some extent, retrenched. *"Curing a culture of corruption across society is necessarily a long-term process and requires the inculcation of confidence in the rule of law in the wider public. That will happen as the judiciary and the public administration change and through education of the younger generation."*. (De Waal, T. 2016).

Preceding events that led to the Ukraine – Russia conflict; inclusive of the unchronicled events via Western Media Outlets: 2013-2021. "Maidan" The most exposed incursion upon a territory by the United States, occurred on December 10, 2013 in the capital city Kyiv. Officials from the Embassy, including the late John McCain were in attendance to give speech after speech professing their loyalty and support to the Ukraine cause. This lay the foundation of another US led coup d'état; to install a new but pro-western president in Kyiv. During 2013 there had been a steady build-up of protests against the then 4th president of Ukraine [pro-Russian] Viktor Fedorovych Yanukovych. Following the US had made their presence felt in Kyiv, the protests escalated in to a bloody sight. From December 2013 to February or the infamous beginning of the "A Revolution of Destiny" -to be more precise the 18,19 and 20th, were the worst bloodiest protests with shots being fired to add to the already existent chaotic scenes, all located in the area of downtown called "Maidan". Maidan is Kyiv's Independence Square. The protesters comprised of Neo-Nazi Groups Right Sector, AZOV and anti-Maidan protesters from at least five Ukrainian geographical locations, including the Russian speaking areas of the South East. It was conceived that the local oligarchs were behind the protest's financing, but as yet to be proved. Subsequently on February the twenty-second, the Verkhovna Rada Committee with its MPs voted to remove Viktor Yanukovych from the post of president of Ukraine citing he was not fulfilling his duties. He then fled the country a short time later. According to Ivan Katchanovski at the University of Ottawa in his paper cited 2015, a sniper: *"massacre of almost 50 Maidan protesters on February 20, 2014, was a turning point in Ukrainian politics and a tipping point in the conflict between the West and Russia over Ukraine."*

Odessa and the Trade Union Building; A Day which will live in Infamy: The Colour

Revolution

On May 2nd 2014, a further protest in Odessa this time supported by the [Russian - speaking]. The rally began well, later the protests were join by nationalist supporters who were neo-Nazi and staunch loyalists laid havoc to a former peacefully organized rally. The Guardian Newspaper [a left-leaning outlet] commented on one of the protestors by remarking "At first we broke through the side, and then we came through the main entrance,": said one pro-Ukrainian fighter, 20, who said he was a member of the extreme nationalist group Right Sector. In the late afternoon, tents were attacked and Russian-speaking supporters were both outgunned and outnumbered. Consequently, the Russian supporting elements fled into Odessa's Trade Union building which was immediately set ablaze by the nationalists. The flames and acrid smoke engulfed the whole building with armed nationalist supporters laid wake outside. The Russian-speakers within the building decided to flee the burning building by jumping out of the various windows or they would have been asphyxiated. Nevertheless, death was awaiting them in one shape or form. Once they dropped to the ground with broken bones, they were finished off with an array of iron bars, baseball bats or simply shot in the head by the waiting nationalists. Alas, the Police were merely watching these terrible events unfold; possibly under Kyiv's instructions. In short, 50 people were either burned alive, beaten with clubs or shot in the head point blank range on this infamous day at the Trade Union Building in Odessa by neo-Nazi sympathizers. The most outrageous aspect here, was that Western media, had hardly chronicled the incident albeit aired it briefly. Not surprisingly Gallop Poll USA, reported that 14% of the population trusted its media.

An irrational awakening occurred in a terrible Summer of 2014; it was Slavic against Slavic from the same sovereign state of despair on the behest of Kyiv and the USA. Furthermore, a German journalist and filmmaker who was in the Ukraine from the outset of the crisis, had documented all news from the region from the Colour Revolution [Maidan] until the shelling commenced in the Donbass Region. Mr. Mark Bartalmai, chronicled an impartial account entitled "Ukrainian Agony" chronicled in his stay, both political and the military

indiscriminate events that had led up to both the Russian acceptance and assistance to the Lugansk and Donetsk regions respectively. A vivid unbiased account and representation of events that led to Mr. Bartalmai and his interpretation of events being vilified, even though, he was present on the ground there, as many other silenced independent journalists were. (Bartalmai, M. 2014).

Following the tragic scenes in Odessa, a referendum in Luhansk, and Donetsk or the "Donbass" Region took place. Also reported by the Guardian, 89% of the electorate voted for separation from Kyiv. If we were to delve a little deeper, Ukraine has in fact, a 40% Russian-speaking populous as indicated below in Fig. 1.

Figure 1. Comprehension of the Divide of Ukraine's Spoken Tongues.

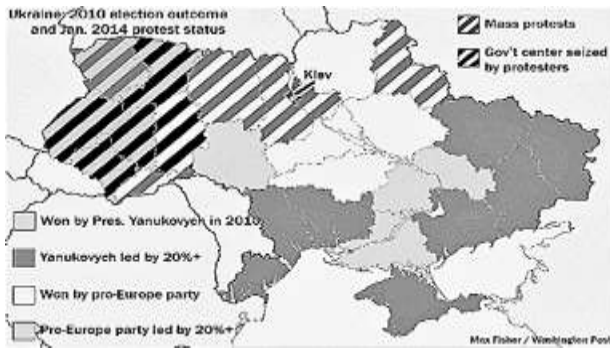

Clearly Fig 1. elucidates that the majority of the protests were situated near the capital Kyiv which represent the Ukrainian-speaking majority. It is also indicated that Ukraine's Russian-speaking populous attributes to over 40% of the country demographically. However, it has also been shown that the Odessa Nationalist far-right fringe who committed those atrocities on the 2 May, 2014 originated from the North East of the country. We must remember, for both the US and NATO, as they have no qualms of this revival of Nazism which has engulfed Ukraine and being incorporated within its Army; Ukraine creating chaos in the Donbass, provides a provides a migraine for the Russian Federation. It is clear in Fig 2. above that the president Yanukovich clearly won his last election via varied electorate. And won within the realm of the country's constitution. Thus, democratically elected. Moreover, there is also a clear divide between the pro-Russian side and the pro-Europeans. These figures reflect the strong possibility for social division and possible conflict.

Between the months of March and April's protests in 2014, There was a Declaration of Independence of the Autonomous Republic of Crimea and Sevastopol was unanimously declared by a margin of 95.5% according to the BBC [who were present] in the referendum and the subsequent joint resolution adopted on March 11, 2014. Secondly, Luhansk and Donetsk voted for separation from Kyiv in their own Donbass referendum held on May, 2014 with the results displaying that the residents were 89% in favour of annexation according to Reuters published on the eleventh. As an important addition, Reuters news in its headline showed clearly the misinformation and demonization of the Donbass immediately following the election results.: Rebels declare victory in East Ukraine vote on self-rule. How could innocent women and children with the elderly be so-called "Rebels"? Since Kyiv's initiation of this eight-year conflict, the West's media has shown bias in favour of the capital city, and there were not any Russian troops in the Donbass region. Following the May 11th annexation Elections, there had already been some shelling and incursions by Federal Kyiv forces.

The Man who Campaigned for Peace, only to become the President for War? Petro Oleksiyovych Poroshenko was elected President of the Ukraine in the early presidential elections in the first round on May 25, 2014, and was

ceremonially sworn in as President on June 7, 2014. (Columbia University. 2015) According to Columbia University's Programs and Events Planning Resources: Graduated with a degree in International Economic Relations. Served in army 1984-1986. With the addition of being pro-Western in his politics, and was the perfect actor/leader for the United States' foreign policy agenda. Now we know why the Maidan was initiated by the US in December 2013, cited on p.31. and consequently, his predecessor Yanukovich had already fled the country. With the data that has been afforded to this paper and segment, it has been coherently established, that this installation of this new president, was nothing more than a Western incited "Maidan" coup upon the Ukraine citizens. Initially, President Poroshenko campaigned on peace for his country and economic welfare with the West: primarily with the European Union, however, according to the Open Democracy Paper the "Army, faith, language" Bill 5670-D, was approved in its first reading on 4 October 2018. Next came the process of amendments (some 3,000 of them), and the parliament passed the law in its second reading on 25 April 2019. Following his act of war commencement upon the Donbass ethnic Russian population with Slavyansk, Luhansk in 2014. The shelling on normal domiciles inhabited by civilians with loyalties to the Russian Federation, had commenced. Imagine a shell landing on a residential neighbourhood within your own country? The destructive force of this weapon is indescribable for the most sensitive reader. Thus, a defensive militia to counter the deliberate shelling of this region was formed, and many visited the recruiting offices. The elderly, women and children were eventually told to evacuate the Donbass region, with only men of 18-60 years old were permitted to stay and fight. The LPR and DPR militias were formed to fight the government forces. L-Luhansk and D-Donetsk Autonomous Republics.

To be clear, Ukraine launched a military counter-offensive against pro-Russian forces in April 2014, called the "Anti-Terrorist Operation" (ATO) a commonly American used excuse noun "Terrorist" was used to give unlimited rights to the Ukrainian Army to basically do what it likes upon the Donbass, - so much so, that from 2014 until 2018, when it was renamed the "Joint Forces; Operation" (JFO). By late August 2014,

this operation was able to substantially reduce the territory under the control of newly formed pro-Russian militia, and nearly retook the borderline. A key point here, to muster support from one's own population or citizenry for an operation so sensitive as attacking fellow compatriots and Slavs, would need to change the wording to "Terrorism" or "Terrorists" - a common US/NATO tactic to convince its own populous of an imminent conflict. Moreover, to use the noun terrorism, then a country's leaders can do absolutely anything -no matter how destructive and heinous it would be. For a period of nearly eight years, Donbass residents have lived in bomb shelters and succumbed to the might of a trained Ukrainian army, with additional Nazi focused battalions in support that has indiscreetly impoverished its own citizens by the shelling of normal housing inhabiting the elderly, women and children. In addition, Kyiv suspended pension payments to these citizens. The atrocities had not ended there. As this paper was being drafted, just under 14,000 people had lost their lives in the Donbass region; 70% being of Russian ethnic origin and speakers. These had included yet, once more innocent women, children, and the elderly. Obviously, the Donetsk and Lugansk Republics Militia Defence Forces representing the eastern regions, sustained many casualties also. "We are going to have peace even if we have to fight for it." Dwight D. Eisenhower. Peace for Donbass citizens, is freedom to both practice their culture, and their language upon their motherland. So, they must fight for it. Is this what the human race protects as a matter of dignity?

The Minsk I agreements were not honoured by Kyiv: As this fratricidal war continued, a meeting in Minsk, Belarus was thrashed-out in 16 hours. This came to be known to this day as the Minsk II. This followed the failed memorandum of similar nature in 2014 as the front line at this time had more stability -until January 2015, when the Donbass town of Dabaltsevo was shelled; with ordinary farm houses and civilians massacred resulting in many innocents' dead. Therefore, Minsk II came into play and modifications were made to the text. Below, is the text from the Minsk II Agreement.

As one is in possession of the whole agreement text; below is a brief version of the agreed terms. Below each article [italics] of the agreement in (*) **parenthesis were the breaches**

of the said agreement. Material provided with compliments of the Financial Times UK:

Package of Measures for the Actual Implementation of the Minsk 2 Agreement, in brief for Simplicity - February 12, 2015.

1. Immediate and comprehensive ceasefire in certain areas of the Donetsk and Luhansk regions of Ukraine and its strict implementation as of 15 February 2015, 12am local time.

(*Dabaltsevo was shelled by Ukrainian forces Jan 2015)

2. Withdrawal of all heavy weapons by both sides by equal distances in order to create a security zone of at least 50km wide from each other for the artillery systems

-for the Ukrainian troops: from the de facto line of contact;

(*The border was being fought & contested once more)

-for the armed formations from certain areas of the Donetsk and Luhansk regions of Ukraine: from the line of contact according to the Minsk Memorandum of Sept. 19th, 2014;

(* Full scale war had broken out by Jan 2015)

The withdrawal of the heavy weapons to start on day 2 of the ceasefire at the latest and be completed within 14 days.

(*The withdraw was opposite; women, children and elderly were ordered out of the Donbass region, only younger men remained)

The process shall be facilitated by the OSCE and supported by the Trilateral Contact Group.

(*OSCE an invalid entity that was validating the shells casings and armaments that had landed on the grey zone of the Donbass)

3. Ensure effective monitoring and verification of the ceasefire regime and the withdrawal of heavy weapons by the OSCE.

(* No ceasefire to speak of, OSCE had become obsolete)

4. Launch a dialogue, on day 1 of the withdrawal, on modalities of local elections in accordance with Ukrainian legislation and the Law of

Ukraine “On interim local self-government order in certain areas of the Donetsk and Luhansk regions.

(* Obviously became obsolete due to all areas of the Donbass were under attack with multiple civilian casualties, and illegal Neo Nazi Groups were recruited into the Ukrainian Army)

Adopt promptly, by no later than 30 days after the date of signing of this document a Resolution of the Parliament of Ukraine specifying the area enjoying a special regime, under the Law of Ukraine “On interim self-government order in certain areas of the Donetsk and Luhansk regions”, based on the line of the Minsk Memorandum of September 19, 2014.

(*Both Minsk 1 & 2 agreements became none and void)

5. Ensure pardon and amnesty by enacting the law prohibiting the prosecution and punishment of persons in connection with the events that took place in certain areas of the Donetsk and Luhansk regions of Ukraine.

(*Mass Graves were being discovered & Civilian Victims 2021)

6. Ensure release and exchange of all hostages and unlawfully detained persons, based on the principle “all for all”. This process is to be finished on day 5 after the withdrawal at the latest.

(*Civilians were being used as human shields by the Nazi AZOV Battalions and other battalions of similar nature)

7. Ensure safe access, delivery, storage, and distribution of humanitarian assistance to those in need, on the basis of an international mechanism.

(*Many humanitarian convoy corridors were blocked by the Neo-Nazi Battalions especially outside Kyiv and Mariupol)

*8. Definition of modalities of full resumption of socio-economic ties, including social transfers such as **pension** payments and other payments (incomes and revenues, timely payments of all utility bills,*

(* Pensions were not paid to Donbass Citizens since the war’s commencement...

Unemployment prevailed. Neither Running water nor Electricity were evident, due to

constant shelling of the regional power stations. Became military strategic targets)

*To this end, Ukraine shall **reinstate control** of the segment of its **banking system** in the conflict-affected areas.*

(*Banking infrastructure ceased to exist)

*9. Reinstatement of full control of the state border by the government of Ukraine throughout the conflict area, starting on day 1 after the local elections and ending after the comprehensive political settlement (local elections in certain areas of the Donetsk and Luhansk regions. Finalized by the end of 2015. **(*Since the Donbass referendum to separate from Kyiv, only war ensued...)***

*10. Withdrawal of all **foreign armed formations, military equipment, as well as mercenaries from the territory of Ukraine** under monitoring of the OSCE. Disarmament of all illegal groups.*

(*Since Kyiv permitted such neo-Nazi battalions as AZOV and the Right-Sector to join the Ukrainian Army as legitimate soldiers, the OSCE became unworkable and had since left the country)

*11. Carrying out constitutional **reform in Ukraine** with a new constitution entering into force by the end of 2015 providing for decentralization as a key element (including a reference to the specificities of certain areas in the Donetsk and Luhansk regions.*

(*Attempts to ban Russian language usage, non-acceptance of the Donbass to be separated with Poroshenko became a President of War not Peace sponsored by both the US and NATO)

12. Based on the Law of Ukraine “On interim local self-government order in certain areas of the Donetsk and Luhansk regions”, questions related to local elections will be discussed and agreed upon. Elections will be held in accordance with relevant OSCE standards and monitored by OSCE/ODIHR.

(*The OSCE is an NGO for the US Government and EU, thus had no real function of service in Ukraine. Its false reporting was on par with the Western Media outlets...)

13. Intensify the work of the Trilateral Contact Group including through the establishment of working groups on the implementation of relevant aspects of the Minsk agreements.

(*Result, both Minsk Agreements failed)

Covid-19 has this been a wake-up call or global reset?

Since we have all experience the pandemic since 2019 until the mild variant Omicron as this paper is being drafted, we have witnessed a regime-minded reset within government leaders placed upon its people; on occasion ignoring the science community. Governments have become both centralised and autocratic/authoritarian within their respect policies. Especially the aforementioned illegal sanctions [unratified by the UN] imposed onto Russia A further prediction is that a weaker dollar would cause a currency butterfly affect which will weaken both the Euro and Pound Sterling subsequently, as 9.74% of the world population reside in Europe and according to EUROSTAT: between 2018 and 2100 the share of the world’s population

living in G20 countries is projected to fall from 63% to 43%, while the share of population living in the EU is projected to contract from 6% to 4%. There lay the thesis.

Why did President Vladimir Putin Escalate the War in Ukraine? Was there a choice or not?

Whilst conducting one's research into how the West has been trying to marshal the world since the end of the USSR inclusive of the breakup of the Warsaw Pact, many variables of contention had to be evaluated. The research included past treaties honoured or dishonoured since the end of the Union of Soviet Socialist Republics. Both the US and NATO actions were included within this segment, and to define what are the true qualities of a state leader? This segment however, will endeavour to connect the prelude section of this body of research i.e., preceding history variables to today's conflict which may have played an intellectual part within logical contextualisation which had motivated the President of the Russian Federation's decision, to ramp-up the war in the Ukraine.

Physician N.D Arnold: *"A good leader leads the people from above them. A great leader leads the people from within them."* In one's geopolitical knowledge of statesmen of the present day, there seems to be [from an analytical standpoint] a true lacking of quality leaders of whom preside over their nations western nations as they follow only one. Could this be the reason why there has been a Western hegemony their allied leaders were either inexperience or weak within international dialogue?

Possible factors Why President Putin Proclaimed his Final Resolution on Ukraine?

Over the assemblance of history, since World War II, there have been many ardent, unscrupulous Western behaviour traits that had led to subsequent actions within both the days of the Cold War, inclusive of the 1969 détente between the US and Soviet Union under President Nixon with a core element of the foreign policy for nuclear arms control, and the events during the Warsaw Pact's folding, the misleading USSR dissolving negotiations between Mikhail Gorbachev and James Baker in

1990.

For President Putin, there were additional elements in Russian Sovereignty afoot within his historic recounting that had and has vexed him to this day. The annoyance came to pass especially referring to President Nikita Khrushchev's surrender of the Crimea Region to Ukraine. Vladimir Putin in a recent speech remarked: *"in 1954, Khrushchev took Crimea away from Russia for some reason and also gave it to Ukraine. In effect, this is how the territory of modern Ukraine was formed."* (Putin 2022,) A further hurtful moment for him were the past negotiations between James Baker and Mikhail Gorbachev 1990-1991, to discuss the reality of German unification; which obviously involved the future dissolving of the Soviet Union. As one is in possession of the Record of Conversation itself. On page 5, Paragraph 6, final sentence of the said document, Baker **guaranteed** that: *"...not an inch of NATO's present military jurisdiction will spread in an eastern direction."* In addition, pp.8-9 [para. 1] Baker asked Gorbachev this critical question *"...and you need to answer right now. Supposing unification takes place, would you prefer: a united Germany outside of NATO, absolutely independent and without American troops; or a united Germany keeping its connections with NATO, but with the guarantee that NATO's jurisprudence or troops will not spread east of the present boundary?"* Gorbachev's reply: *"It goes without saying that a broadening of the NAT zone is not acceptable."* There lay the foundation of US misleading information which has continued to this very day. Even though Baker stated guarantee in two tense forms and Gorbachev countered with a stern non-expansion response, this agreement became a farse in recent memory. According to Von Clausewitz: *"Is not war merely another kind of writing and language for political thoughts? It has certainly a grammar of its own, but its logic is not peculiar to itself."* In fact, NATO *cum* the US in their mental judgement, did expand; they have indeed ameliorated this agreement for their own benefit. Therefore, promises unkept. Actually, since the aforementioned meeting with the US and the Soviet Union in 1991, NATO has since surrounded Russia's Border except for Ukraine and Finland. In fact, they added 14 more members rapidly from 1999 to 2020.

In addition, the president of the Russian federation has witnessed many prior agreements not honoured inclusive of both Minsk agreements. His foreign minister had reached out to the other side on countless occasions to no avail.

Irrespective of being from the East or the West that in light of what has been occurring in the East of Ukraine for eight long years, and the history of the Ukraine and past events since 1991 with more broken agreements, President Putin has been extremely patient compared to some Western leaders of the past. Additionally, had his Athletes, Musicians Chess Players of whom are not related to politics, been vilified and being cancelled for major events. Moreover, his Sputnik V vaccines being banned for some time in Europe, without scientific evidence. This premier has seen western politics has been increasingly involved with all aspects of life, where it needn't have been. If the reader were to be a nation's leader with all that has been discussed within this paper, would you protect your ethnically body of individuals following their cry for help, as they had been subjected an 8-year shelling spree on their ordinary farming and mining neighbourhood communities by tanks, D30 cannons, occasional Jet aircraft and helicopters? One awaits your answer.

The Rand Corporation: Unbalancing Russia.

If the former examples were to inflame tensions with the Russian Federation with the West was not enough, the RAND Corporation however, is an American non-profit global policy think tank which was founded by Douglas

Aircraft in 1948 that is involved in conducting research and analysis directly to the United States Armed Forces. Its funding emanates from the US government, private endowments, universities and other entities. A brief published in 2019 entitled: ***“Overextending and Unbalancing Russia”*** suggests strategies to weaken the Russian Federation. It states Russia’s *vulnerabilities, Western inspired regimes change* cited on p.2. On pp.3-4 the research findings are as follows: *“Expanding US energy production limiting Russian revenue, does not need multilateral endorsement, imposing deeper trade & financial sanctions and ability to import gas from suppliers other than Russia.”*

The most notable suggestions were highlighted on page 4. These covered four main points: ***“increase military arms and advice to Ukraine – without provoking a much wider conflict, promoting the liberalization in Belarus, and reducing Russian influence in Central Asia.***

Does the reader recall the recent 2022 Winter Olympics and global sporting events? ... well, if one refers to p.5 (Para 5) of said report, *“...boycotting such events of the World cup could be implemented by western states and would damage Russian prestige...”*

To be clear from this analysis, this report or “Brief” was commissioned in 2019 -three years ago, and appears to be an Orwellian moment of truth. These aforementioned suggestions to the US Government were carried out previously, but failed in Belarus. Conversely, a mirror image of this brief has been conducted in the US involvement within the Ukrainian conflict. Therefore, this was a plan of action to usurp the Russian Federation via a hidden US Declaration of War upon said nation.

As for NATO:

NATO: the North Atlantic Treaty Organisation itself is in need re-naming. Certainly, it has been discussed that it wishes to facilitate a global expansion ambition apart for being a vehicle for the US Dollar. One suggests retaining its acronym, however, change its definition. One would modify this slightly as: North American Treaty Organisation NATO as it ascribes to be the purveyor or harbinger of peace, the three aforementioned incursions notated in the previous paragraph, have disproven this narrative. Furthermore, when the USSR disbanded in 1991, NATO should have done so

too. If world nations were to solve issues and conflict “Regionally” both the UN and NATO would become obsolete.

The West and its Negation of Freedom of Speech

This topic ought to be mentioned as an additional element which has relevance to the political diplomatic process. The research however, uncovered probable reasons why both positive and meaningful dialogue has been absent within the political sphere. The US and Europe have actually changed or had a negative renaissance with regard to human interaction for some time. Freedom of speech, expression, debate and creative thought and ideas have all been stifled in western society. Students could be “cancelled” from university if untoward phrases which were normally spoken a generation ago, or in commerce, employees could be removed for similar conduct. Many individuals are indeed fearful of losing both their studies and jobs due to this shunning ideology deriving from the 1930s. It is written: *“At board meetings across the country, reasonable people occasionally misspeak. People without a biased or racist bone in their body, but who are unfamiliar with the demands of the left and ignorant of the magic word de jour the left demands be used, cause offense; real or imagined. In response, cancel culture demands their immediate social execution. They are vilified and held up to ridicule. If the organization to which they belong does not immediately meet the demands of the mob, they are deemed complicit.”* Bridges, D. (2020). Therefore, how could a nation’s leader within political dimensions, could negotiate with the West in crisis talks: *per esempio*, Ukrainian dialogues, since ideology has engulfed one negotiating party and has no care for its own population. Sanctions hurt the ordinary man or woman in the street, rather than their leaders implementing these unworkable economic punishments.

This research summation possibly could have possibly exposed a further factor in negotiation failures, as this has never been cited by political scientists with regards to a possible anomaly, in which stalemates or impasses in the War of Ukraine, have been continuously occurring. Furthermore, Since the American backed “Maidan coup in 2014 suggests, that the Minsk agreements are related to the said “Cancel left-leaning political oriented beguiling

ideology” towards Russia. Under President Biden’s administration; the WWII mandates of Nazi Germany, have returned regarding US-Russian relations, however, under the 45th President’s reign, there was some acts of friendship and more importantly, dialogue. It was actually the UJS “Republican Party” that limited a more productive atmosphere.

Under [it seems] the worst US President beyond living memory, this leader’s unhelpful, divisive rhetoric, could be an addition to an unhealthy *cum* unfortunate detestation of the Russian Federation. Thus, another viable reason why President Vladimir Putin lost intellectual patience with the West. Furthermore, it has been the misinformation which has had an addition helper for the US current administration. This paper’s hypothesis underscores the fact that fascism had never left the West and its ideology. A case-in-point would the infamous Dr. Paul Joseph Goebbels; two statements he stated: *“Let’s clear Germany of Un-German ideas”* For the US, NATO and EU, it transposed as *“Let’s clear the world of Un-American ideas.* As for revisiting media disinformation, Goebbels also in proclamation: *“Repeat a lie often enough and people will believe it”* To exemplify this further, even under president Obama, a Harvard academic once wrote: *“As I follow the news on the so called “Obama gate” so called scandal, I am reminded of the famous statement by Nazi propaganda minister Joseph Goebbels”* (Kelman, S. 2020) Here, Dr. Kelman [a left-leaning] academic, used the *famous statement*, for it was famous as it is currently being inferred in the West [especially] the democratic party’s administration, NATO -now the EU, as they have used this form of Goebbelist repetitive form of misinformation technique, against the Russian Federation. Consequently, for the West to support a nation that has a vast history of Nazism (which has been cited) i.e., Ukraine. The Acronyms Club actually verifies that the it has justified itself as being fascist, then tried to negate it politically in WWII -following reports of a holocaust that had taken place under the Third Reich. However, when its narratives are countered or challenged, it finally reveals itself, alas, once more. In fact, it was president Vladimir Putin on February 24, 2022, who actually was the first world leader to counteract the bullying tactics from the United States. As the Slavs and Jews were ostracized prior to their

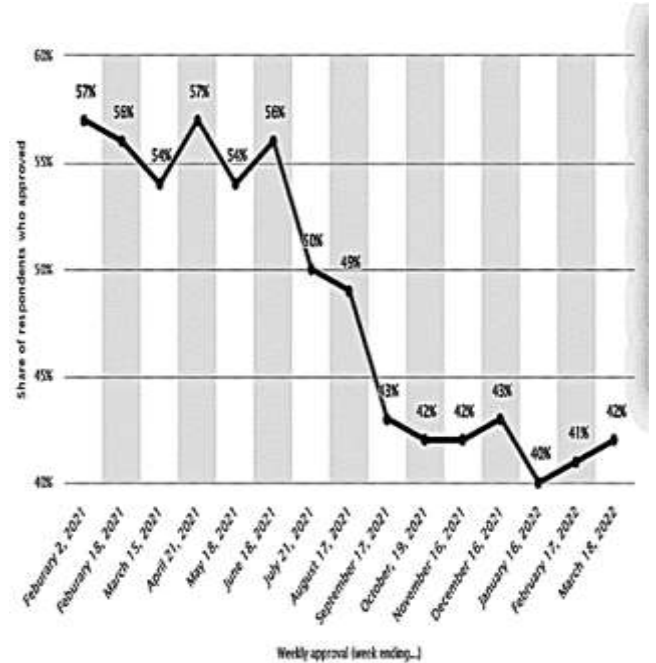

The annals of history cannot be removed, as it has already occurred and been documented.

To conclude this segment, inclusive of all the previously stated data presented within this section, how could President Putin, or any leader, experiencing media misinformation from their controlled entities of which possess documented poor human rights records themselves, be so patient for many years, -especially during the 8-year bombardment of the Donbass region. What is a leader to do in this situation? As a Statesman of many years, of whom, possesses a huge army inclusive of modern technology, - both knowing and experienced the odious, ignominious documented historical actions and nature of the Acronyms Club, and its practices, one would ask: What should the Russian president ought to have done, in these precluded circumstances?

The West's Narrative Compared to Actual Fact? -Analytics

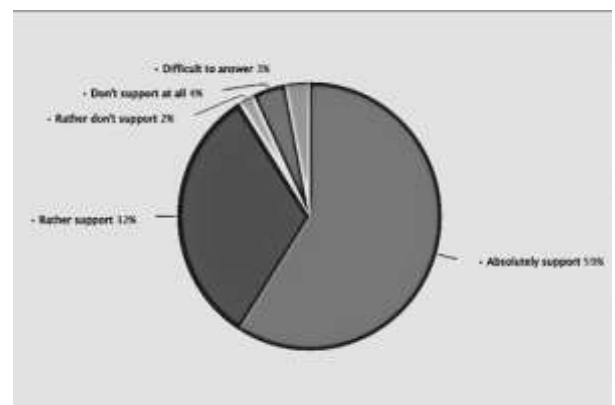

Figure 4. Polling Statistics for Joe Biden up to March, 2022.



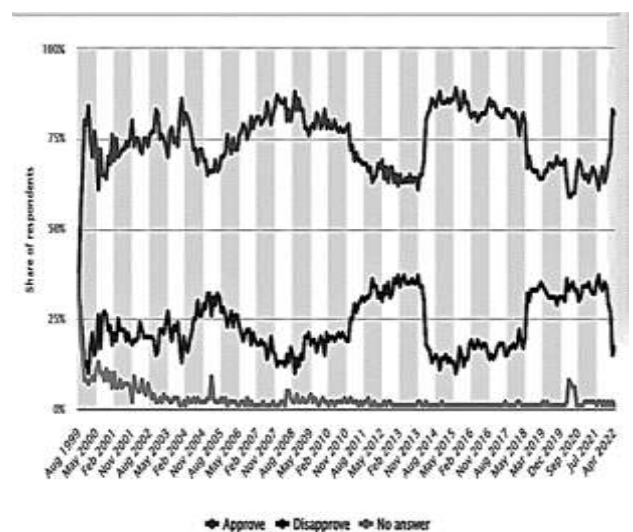

According to the data charts above represented in Fig. 4-6, using a global model indicator: President Putin's polling had stood at the same time according to "Statista" was very comprehensive: in the years: 2013 (63%) 2014 (86%) and April 2022 (82%) [with shortfall of (54%) for Covid-19] this comprehensively shows a mean favourability rating of ~71% compared to President Joe Biden (US) March 2020, decreasing month-on-month at (42%) with President Volodymyr Zelenskiy having a favourability rating in wartime at an unconvincing ~ 59% with his citizens, for April 2022. (Statista.com 2022).

When a similar survey was conducted by the Tass News Agency, the question asked: "When asked directly about confidence in Vladimir Putin", 81.5% of the Russians polled answered positively (plus 0.9%); the level of approval of the Russian president's work from April 25-30 was 78.9% (plus 1.2% over the week)," the report notes" where the Prime Minister was at 54% when this paper was drafted.

Research Findings

To fully answer the question within this body of research's initial hypothesis - Why did Vladimir Putin, the President of the Russian Federation, purposely venture into Ukrainian territory, via its "Special Military Operations" and was there provocation from the West prior to doing so? As the reader has observed throughout this paper, the draft has also delved into fascism in the West via several historical events. It has been discerned that the fascistic nature of the Third Reich, was not the first ignominious venture into fascism itself. Moreover, this has become the most comprehensive research from the historical perspective of the West, conversely, up-to-date papers written this day, have been biased, thus, eliminating science practice within data gathering onto its analysis from an objective standpoint. For this researcher, this was unsurprising, as similar thesis models were applied during the Covid-19 pandemic by reputable men/women of science. Therefore, recent papers fully versed on this subject matter were scarce. Therefore, this researcher gathered from documented history for context and prove the hypothesis in many ways to discern the full picture of this Ukrainian crisis and its objective datasets.

As the research commenced with the

portrayal of the origins of the political process of "Democracy" from its founding, the use of Cleisthenes's version of *Demokratie* [P.1] led to his own death in the fourth century BCE; as this form of electoral representation was taken too far and led to a totalitarian form of statesmanship. However, today's democracy is another failed version that has been sold to the world by both the US and/or the Acronyms Club for over a century. In fact, having made a comparison within its negative historical origin and the way democracy has been marketed in both the 19th, 20th and 21st centuries respectively, it is clear that this failed system is not suited to all nations in the world. It cannot replace civilizations, their cultures, own histories and religious processes, as this is defying nature itself. Even Hitler once defined this as to bring order, security and democracy to the world. Where is the punishment for these misdeeds? As it was commented earlier in this study that democracy means different things to different peoples. To add more clarity, US journalist Eric Lichtblau once said: "*American exceptionalism cannot be punished for its actions, and seems to be immune to creating conflict.*" With reference to *exceptionalism* as a known research concept, in summation, this reference comes to mind: "*If however, the concept is applied to American identity, there is an important distinction to be made between exceptionalism and unilateralism. As the public opinion data has shown, it is well possible for the public to hold exceptionalist beliefs about the US, without displaying unilateral attitudes with regard to American foreign policy.*" (Thimm, J. 2007).

As Hungarian historian Tamás Krausz, once remarked on the Ukraine situation in a 2022 RT News Agency interview, he had inferred that the real animosity against Russia, commenced after the fall of the Soviet Union, and globalism had brought many negatives to the human race. This confirms one's thesis that all the issues being experienced in the Ukraine, emanated from 1991. However, this paper had broadened this subject matter's scope of research, to WWII. In light of how Nazi sympathizers from Ukraine, or its collaborators of this epoch, were involved within

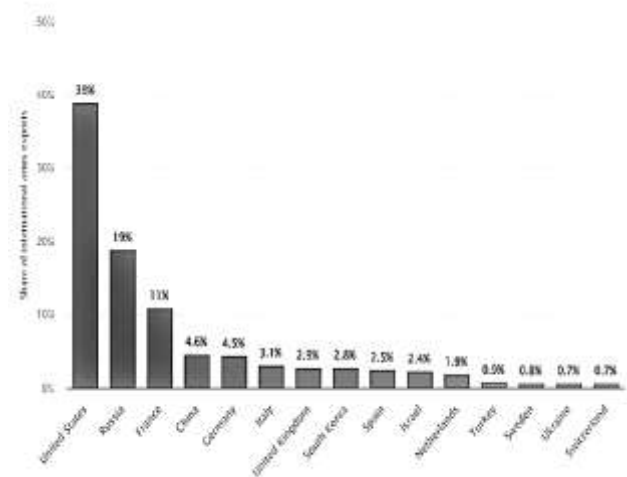
the Waffen SS as the Germans invaded Russia in 1941, and inclusive of being concentration guards at its infamous concentration camps [P.10]. Today, this strident hatred of Russia, indeed exists within the 2022 conflict, and evident with the countenance of President Zelenskiy, as Far-Right battalions were included within the Regular Ukrainian Detachments, thus, being unqualified in Rules of Engagement, initiated the attack on the Donbass region in 2014. The regular army had not wished to shoot at its own citizens; some left the region; others eventually joined the newly formed militia forces which became the Donetsk People's Republic forces. Consequently, the Nazi-Winged forces of the army, with their SS Skulled insignia adorning their military fatigues, had no qualms in attacking innocent citizens; as they were extremely radical. The crimes they had committed thus far, ranged from looting, rape and indiscriminate executions. This being said, the West and its media, deliberately hid these abominations from the public and therefore continues unabated.

Following the analysis of a three-year study both prior to and during this conflict on the 48th parallel, it is without dispute that the US-NATO-EU members of the Acronyms Club, have indeed both provoked and continually aided/used/proxied Ukraine, as a tool of provocation toward Vladimir Putin, hence, being the causation factor of Russia's Special Military Operations from February 2022. This study had also ventured into the various Modi the USA has used to overthrow or attempted to overthrow independent nations within the annals of history. The assertion is a modest one: if a country defies the US, and has an advantageous geopolitical corridor, or has profitable natural resources within, it easily becomes its foe. If this media-created adversary were to continue ignoring US international

policy, then it will be certainly targeted in other ways: vilification from biased media sources, being labelled as a terrorist state or dictatorship and enforcing economic forms of sanctioning; - all of which, would convince the American people. Phase II would be the persuading of NATO members to join; as the US would not like to have blood on its hands directly. This paper had already mentioned that NATO is neither for peace nor democracy, it is merely a vehicle or Chariot of War for globalism, neo-liberalism and a money-making mechanism for arms manufactures as the US leads the world for Arms Sales. Fig. 6. represents the percentage of exports globally, however, the data also shows that according to Statista, the graphic clearly shows that the Acronyms Club is responsible for 64.9% of all global exports for 7 nations illustrated. [Ukraine excluded] Moreover, the top ten profitable firms holding profitable market share in the world are 1. Lockheed Martin Corp 2. Boeing and at number three globally 3. Raytheon. but the UK's BAE Systems is at number 4. 7. Airbus group (Trans-European) 8. Thales (France) and ninth Leonardo of Italy. Conversely, Russia's Almaz-Antey is at number ten in market valuation. Conclusion, the Acronyms Club contains 90% of the top ten arms exporters in the whole world.

In fact, the United States has never been directly affected by the conflicts it has created,

and its citizens have never been directly attacked militarily on its own territory. Pearl Harbour in Hawaii was attacked by the Empire of Japan in 1941, however the islands were not officially of the US, until its joining as the 50th State with Alaska, as previously cited in this paper, in 1959. The result, an emboldened US being a conductor of an orchestra of death, destruction and the removal of a state's sovereignty -Until, the Russian Federation stood its ground and defied it.

The data has also shown that the Acronyms Club has used falsehood, inuendo, and misinformation, to have its way upon the world. Case-in-point, the former USSR-USA Summit 1990-1991 [P.17] had proved this thesis first, and second was the defining moment on February 24, 2022, whereby the falsehoods and unbroken promises by both Ukraine and the US, had led to Vladimir Putin initiating the Special Military Operations in defiance of the untrusting western nations. Additionally, NATO as an entity was really redundant following cessation of the "Cold War" It neither had no real purpose nor meaning; in fact, functionless. Conversely, this study has discovered beyond theory that the US with James Baker, had no intention of honouring its agreement with Gorbachev in their meetings *circa* 1990-91. "...not one inch...eastern direction" Baker had said. [P.17] This would always be a huge strategic opportunity for the US and NATO allies. With the data both recorded and analysed, it has been determined that following the collapse of the Soviet Union and the Baker-Gorbachev agreement signed, was in fact, the proverbial starting pistol for NATO's expansion.

The United Nations was formed in 1945, following the failure of the League of Nations, this study has seen that due to its biasedness towards non-American policy, but not compliance to the globe's demands for inquiries against US war, coup, and the creation of failed states polices it is clear it isn't a neutral body. As previously discussed, the deliberate attacks on the former Yugoslavia in 1999 was not agreed to by the UN's Security Council, even Noam Chomsky called this "*an act of terrorism*". The second unsanctioned act of bombing of Baghdad was justified by Bush and Blair for another reuse; in this case, the invisible weapons of mass destruction (WMD). That being said, the US once more was not sanctioned for war crimes.

According to Blum's table [P.4] how could one single nation be involved in the attempted changes of other sovereign countries' governments 72 times, and were not ever sanctioned? This alone, has brought the UN into disrepute, and ought to be disbanded and therefore be made redundant under these historic auspices. A suggestion that came to mind during this study, is that nations geographically close in location, ought to form their own respective coalition working groups to solve their own affairs without US interference. Furthermore, why have nations of which are unrelated in both culture and geopolitics, vote on resolutions in the UN Security Council, without bearing any relationship towards a specific conflict zone? It is illogical if India, were to have a further conflict over Kashmir with neighbouring Pakistan, and a group be formed comprising of Iceland, Ireland and Togo were a part of the negotiation process. As ridiculous as it may seem, this is how the UN has functioned over many decades. A unipolar world as the Acronyms Club has prescribed, which has been proven in this study, is at a timely end; it's unworkable, illogical, untenable and biased favouring the United States. It has lost or never has been completely neutral. The data since WWII therefore to prove this hypothesis is unquestionable and beyond debate.

Since the escalation of the Ukrainian conflict, the datum has displayed the histrionics of Ukraine in reference to Nazi sympathizing, government corruption, leading to a US coup d'état in 2014. In infinite wisdom, for it to join the European Union and its very strict fiscal qualification criteria, it simply had no chance. Moreso, the limited chances of joining NATO. The evidence has shown that Volodymyr Zelenskiy has been coerced into escalation with the Russian Federation by the United States only. As NATO is under the command of the USA in the first instance. A Jewish comedian *cum* businessman who has suddenly expanded his wealth exponentially since becoming President, has ignored many requested peace negotiations from and also stated live on TV that he would like to be nuclear power. To be clear, the evidence is undeniable and irrefutable that Zelenskiy was goaded into an expansionist-lengthy battle with Russia by the USA. The inexperienced President Zelenskiy is a dangerous conduit for US, hegemony and has no care for

the people. A lesson indeed taught by the West. The data has also illustrated that the Acronyms Club members used its media battalions to hasten President Putin's riposte to the intense provocation. As any leader would have done, Putin merely reacted to the requests of the Donbass region for assistance following Russia's recognition of Lugansk and Donetsk independence from Kyiv. The escalation was result of American meddling, for its arms companies and to paint Russia as a negative ogre to expand NATO even further by the influencing of both the Baltic States and Scandinavia; even though perfunctory. It short, make NATO larger and increase arms profitability in sales. According to Sara Flounders a noted political author of several books, a member of the Secretariat of Workers World Party, inclusive of being principal leader of the International Action Center, said recently that the US and NATO had wished to drag out the war.

As the conflict continues on the 48th parallel, the Sanctions Policy is asserted to be a further failure for the West. To militarize the US Dollar has been and will be, a tremendous blunder. Thus, Russia's demands for its energy supplies to be payable in Roubles, has changed everything within the macro-economic arena. Moreover, the repercussions have not only affected Russia, but everyone. For the planet itself, it has become a perfect storm. Yet, more US interference, coupled with Covid-19 and economic sanctions, has led to this. Sanctions is a war on a foe and a silent declaration of it. Resulting sanctions leads to poverty, starvation, and lack of medicine for malaise, therefore, not only bullets or shelling kill people. It is one's academic assertion that the West and its agents the entitled Acronyms Club knew that the world would be affected by these sanctions. Could this have been a plan to deflate third world countries, so at a later date, impose more loans from the IMF/WB, thus have a more controlling factor over said nations, which will result in more control over their Central Banks and once more, negate their sovereignty, with the removal of their dignity? One would allow the reader to draw conclusions of their own. As an intellectual once said: *"It may be true that equality is inversely related to the freedom to dispose of and make use of property under the social arrangements of capitalism"* (Chomsky, N. 1976)

The western media's notion that the Russian

Federation is without allies, is simply another false narrative or untruth. Empirically, from this research it has uncovered from various interviews that Central America, South America, Arab Nations, South Asia, African States, Central Asia and some located in South East Asia, are refusing to apply sanctions to Russia. This information by all sense and purposes and rationale, is quite a huge body of people. Many are indeed surprised with Germany's U-turn in reference to cutting gas ties with Russia. If one were to delve into history once more, it can be seen that German Government under Oscar Fischer has internal issues. The Green Party was formed in May 14, 1993, in Karlsruhe. This was a cohesion between alliance 90 founded by Oscar Fischer and the former Greens. Ralph Nader and Winona LaDuke were voted into leadership of the Greens, and have always been anti-Russia. This merged party's European parliament members involved has led to several vocalised anti-Russian statements. No surprise therefore, Germany has reneged on its energy contract with the Russian Federation.

As notated in this drafting [P.16] Europe has 9.74% of the world population, and the US has 4.73% according to *Worldometer Live* at time of publication. Consequently, the US and the EU only contains 14.47% of the world's total population, and it has controls or dictates to 85.53% of the remainder. Economically speaking, the power emanates from the US Dollar. As the dollar becomes less used for international transactions, it will gradually lose value and will lose its reserve currency status. As the data suggests, 85.53% are a lot of customers. Arab OPEC nations are considering selling to countries within their domestic sphere of currency. An amusing but true statement came former CIA Analyst Larry C. Johnson stating that even drug dealers and suppliers are paying and accepting Euros now, alike rats leaving a dollar ship. Within this conclusion, it is one's strong assertion from all the analytics being evaluated that as long as the US dollar is the world's reserve currency, America could always impose sanctions on anyone of whom doesn't comply with its foreign policies, and will be targeted subsequently. However, it also affects the countries who have less foreign currency reserves. These limit countries' spending power to afford purchases as the importation of both food and medicines. Cases-in-point, were

Venezuela following intense sanctioning, had issues procuring Covid Vaccines and presently, Sri Lanka is on the verge of becoming insolvent. All inclusive of the main export from the United States: “Inflation”.

Delimitations

The parameters within this research were to merely use the data, which has already been defined, in the public sphere, and still within the framework of international debate, however:

a) Data which has not been included, are citations pertaining to in rhetorical nature that is still been litigated within both national and international jurisprudence guidelines. Thus, this aforementioned literature will not be included in any statistical nature of this draft.

b) The main aim of the data used is a comparative of bi-entity within conflict, simply put; an analysis of why there are two entities of both similar and dissimilar demographics have been throughout history, part of a larger world-ordered plan of action.

c) The procedures and methods that have not been undertaken are elements such as statistical questionnaires and direct scholastic/journalistic inquiry via face-to-face interviews (Direct Engagement). Research Main Conclusions

Upon the escalation of the Ukrainian Crisis, following the Global Pandemic which preceded it, many observations came to fore during these two episodes. Initially from a four-year observation of international affairs, became a four-year research project, as many further questions in Western behaviour needed to be both analysed and answered. It had seemed that the United States were trying expand its

hegemony over the rest of the globe, but in fact, it was trying to preserve it.

Upon receiving more credible data, more historical variables were required akin to an etching upon a canvass for contextual continuity. This finally added a final hypothesis question: why did Vladimir Putin, the President of the Russian Federation, purposely venture into Ukrainian territory, in “Special Military Operations” and was there provocation from the West prior to doing so?

To commence this summation, it is relevant to illustrate what the word democracy means to America, and how its dwindling application of hegemony, could assist a foreign nation in today’s growing multipolar world? Permit this research to uncover reality, not propagandised rhetoric. A nation who wishes to dictate to the world, needs to have its own domestic affairs in order. In other words, what can America give us?

The United States has used NATO “Chariot of War” for its own work since WWII, -to remove itself from sole blame for its disastrous incursions, merely, to gain another’s natural resources. The uncovering or unpacking of the data, unveiled what the US is today, and why shouldn’t Eastern bloc countries ever confide in it? Domestically, the USA is a failing 244-year immigration experiment, that is paying the price for its internal constitutional system. Laws are continually being modified by executive orders; therefore, crime has increased there exponentially. What is good about living in this form of environment and its modus of democracy? Constant wars and premeditated coups prevailed upon weaker nations, and the use of its allied entities to indeed fight its battles for future financial gains became the norm. Some recent events would be vilified by other nations, for example, the teaching of sexual education to 6-year-olds at school, the denial of parents to supervise their child’s upbringing with the addition of introducing homosexuality to the same age ranges via educational platforms with reforms. How would this be accepted by strong Christian nations and countries of which profess codes of the Qur’an? The current democratic party and its administration under president Biden, has made matters intolerable -even to ordinary citizens in the US. University graduates have now become weakened under the stewardship of left-leaning professors in the most notable schools of thought. In fact, creative

academic thought, expression and debate are now deemed as cancelled. When America coughs, the UK gets a cold. This has been evident since the 1970s and therefore, the United Kingdom has become akin to the US. America has provided the world with cancel-culture and the demonisation of traditions and their ways of life. Also in the 1970s UK, it was duped to join the Common Market, a reuse for losing 80% of its own laws.

Race-baiting has become a further US norm, with unproven global warming and moralising epithets. In short, the USA is a money-making machine by all means possible. Its huge companies dominate the White House not its elected president and former presidents. Its electoral process has been brought into question, as hardened criminals are being released immediately following arrest, and others are being released or de-incarcerated from long jail terms. The readers of other nations must ask themselves, why should its own nation take US democracy seriously?

The NBA and a hotdog, isn't enough within a country's macro-economic policy, border security, and tendentious evaluation of its history from a nation several thousand kilometres away. As the data has exposed, US bullying tactics upon NATO and EU nations, came to an end when Russia openly challenged the US disinformation narratives in Ukraine. It has also been discovered and well documented that US hegemony is dangerous for the world, as it denies the sovereignty of other nation states. Foreign Religious, cultural values and constitutions are not a concern for the Acronyms Club and the US as its leader. Consequently, A war is good for the Acronym's, Club, no matter how many casualties - mortalities it creates and therefore inflicts. As America is immune to UN Security Council's Article 3 and 6 anyway, war is good for business; however, foreign citizens are a small price to pay for the making of billions in US Dollars accrued over vanquishing time. Therefore, the United Nations is run by the US.

Revisiting US domestic policy, the country is divided by emotional led politics on one side, and traditional conservative values on the other. To have open borders, indoctrination of children to be passive in the future and the cessation of drilling for oil from being energy independent, can only be interpreted as a deliberate act. From well-written academic articles pertaining this subject matter, "Socialism" is to divide and conquer, leading to state ran domination, - answerable to every facet of life. In effect, America could neither survive 4 years of Joe Biden nor the Democratic Party. Both Germany and France mimicked US policies over the years by the threatening of weaker nations into debt. Greece being bankrupt at the behest of these two nations was a disgrace, as the other members sat on their proverbial hands and said nothing to defend a fellow member. Today, Greece is experiencing an exodus of its youth i.e., its future generations, thus, a brain-drain scenario. A further question to be asked is how two nations that had surrendered in WWII; being France and Germany in different courses of the war, be solely in charge of the European Union? As it has been hypothesised within this paper, the

This study has confirmed its thesis that only weaker nations that possess natural resources and having strategic importance, have been targeted as they have not complied with western so-called misled forms of its democratic modelling. In addition, authentic leadership has proven to be more powerful than any form of western states' governance.

It has also been ascertained that NATO itself should have been dismantled following the end of the Soviet Union. Moreover, the US deliberately saw an opportunity to fill the void that had remained. The West sought itself realistically to wage a war on the nature of things globally. The more powerful it became; the more incursions were prevailed upon weaker nations for resource profit and geographic strategic gain. The more recent actions of the West, had displayed its true nature of intent. The 7611 sanctions against the Russian Federation have in effect, weaponised the US Dollar, thus, the exposition of western policy was confirmed.

Suggestions and Possible Solutions for Discussion

As this research came into being, there were many thesis questions that had to be answered to form a credible hypothesis for the reader.

Following the analysis of several models in data streamed formational sets, objectivity was retained, even though, some of the variables uncovered were beyond objectivity. It is clear that if we refer to democracy as an Athenian theme, then the West has failed, or it is not democracy within itself. The contention within this body of work, has the meaning of fascism evolved into a multicultural one? Nazi fascism under Adolf Hitler was powerful leadership and preservation of a race, colonial invasions were of one race was in complete power and masters of the people. European immigration virtually wiped out the Red Indians in the Americas and the Nazis were against non-Aryan races -especially the Jews. Additionally described previously on p.6. Hitler was in fact, preceded by the British Colonies in South Africa for concentration camps in the late nineteenth to early twentieth centuries. White fascism had prevailed there also. Therefore, one's assertion is that fascism within both its meaning and dynamic has not altered in time. The democratic party of the United States, supported Hitler up to a stage until the early 1940s, until Nazi crimes surfaced. Today, it is racial politics for the minority vote that matters, not their own welfare. However, when it comes to warfare or going to war, both parties Republicans and Democrats are in unison in their respective warmongery, due to their self-interests within the US lobbying process. Once the incentive is money, even the citizenry is sacrificed in the process by its elected politicians.

Possible Solutions and Recommendations for Eastern nations

i) The first solution to solve this world dominance situation is to divide once again into two regions of the world; East and West. The former Cold War, kept everyone in check. The US and NATO upon the data gathered and citing their neglectful respect of a nation's sovereignty, it is clear that the Acronyms Club cannot be trusted by the East as it has never been brought to Justice for its own crimes against humanity.

ix) Overseas Educational Scholarships to be limited to countries of similar geographic and cultural agreeable nature.

x) Internet access ought to be subjected to cultural and historical ties, with intense firewalls. Thus, eliminating unnecessary future conflicts via misinformation wars.

xi) Regional Trade Organisations be applied for fiscal stability via the Gold Standard.

xii) Academic work to be only shared with regional parties, unless of global emergency.

xiii) A Regional World Health Platform be adopted and WHO be eliminated, due to poor performance in the Covid-19 pandemic. From documented recording, has become political, instead professing itself to the health welfare of nations.

xiv) Western NGO's (Non-Government Organizations) be eliminated from participating in eastern states for both security and political purposes.

xv) An eastern version of NATO be formed as a deterrent, considering past western endeavours inclusive threats of future interventions.

xvi) Social Media Platforms: Legislation per country, for they to have a publishing licence. Removing or so-called "Cancelling" only can be conducted by a licensed publisher.

Final Synopsis

Following the drafting of this paper and the analysis of the data, the historic variables in western strategic actions have clearly shown that it is the civilian populations that indeed suffer the most from outside interventions. In particular, citizens of both the Ukraine and Russia have clearly suffered under both Nazism and US hegemony. War serves a useless purpose unless it is unavoidable or another nation has incited it. Yet, once more, the USA has deliberately forced conflict within a sovereign nation to arbitrate penalties on its foe, being Russia. The evidence also suggests, that in light of US interventions past, that the Ukraine crisis was neither initiated by Russia nor Ukraine, but by the Acronym's Club. Correlation therefore, suggests that individuals who are in possession of credible opinions are cancelled, thus, is intellectual reasoning being challenged?

From the evidence cited, it is axiomatic that Russia within its history, has been targeted for destruction. From the many plans that have been uncovered for the modus of attack. Since the end of both WWII and the dissolving of the Warsaw Pact, the US has 60 military bases around the world, and according to a reliable military website, the Russian Federation has ~16 in its entirety. The crisis in Ukraine is indifferent to the

annals of history. To elucidate further, a known country of corruption with an inexperienced leader, was easily manipulated into war via promissory notes of ill-repute and without foundation. Monies for acquiescence to the US, has placed the citizenry in mortal danger. The death nail for the US and especially the United Kingdom, is when they became less productive to be rather financial houses, as the Eastern states have kept producing to fuel its economic engine. Both the UK and US have never recovered from deindustrialization; they subcontracted manufacturing outside the countries and paying the price for these sanctions against Russia. Why would the West be sanctioning producing nations? There lay the error, by weaponizing the US Dollar, this has prepared many nation states to wean off this currency. The Russian Federation has long since planned for any future sanction actions towards its boundaries. Iran and Venezuela were an omen for Vladimir Putin. China, however, is too heavily involved with exports to the US, and is now preparing for the on-set of sanctions in their direction. Within the next four years, the US dollar will weaken and other currencies being Sterling and Euro will follow. The East will keep producing and the West will be reliant on paper. Central America and many South American States will remove itself from US domination and trading ties. Also, Latin, African and Eastern continents will form their own cooperatives, following the Russian model. Neo-liberalism as we know it, is coming to an end. Being threatened, taking on loans from the IMF, being indebted to West will depreciate over the few years. What this Ukraine escalation by Russia has done, is to expose the true nature of neo-liberal geopolitics and the damage it has caused to sovereign nations. We must ask the question; who produces more in life sustaining products or commodities today? The West produces more pension and insurance plans rather than food goods; life sustaining therefore. In short, the US and NATO, are experiencing the lowest opinion rating globally since the ending of the Cold War. The neo-liberal new world order they had indeed envisaged or perceived, has unexpectedly created a Cold War 2.0, but in the favour of Eastern nations. They will endeavour to use their own domestic currencies within the gold standard to facilitate trade deals. Consequently, the US dollar will lose its Reserve Currency Policy. The remainder of the world has lost trust with the Acronyms Club, as it has politicized everything from, scientific research, medical

treatments, logistics, education and to using a dystopian narrative to fulfil its egotistical fascist ideology. The world requires feeding, health solutions and leaders who place kitchen table issues first.

As one restates: International Law only exists to serve the US, NATO and EU, if it doesn't, it doesn't exist. Thus, regional regulations need to be instilled within the Eastern Bloc rather than the one-sided regulations in which the West subsequently ignore.

Prediction and the Reality: The Eastern Bloc will be and has been forming from Serbia onward; including, possibly Hungary. This bloc therefore, will include Eurasia, South Asia, Central Asia and South East Asia. This will be the largest ever separation globally as we compare it to post WWII.
